As these two (2) employees are nearing retirement, the necessity for departmental reorganization to meet ongoing needs of the department has occurred. The two additional DDSSA Program Director positions, are necessary to provide the outstanding leadership services that the State of Arkansas has been known to provide. The DDSSA Program Director holds the responsibility of supervising and directing staff members to ensure program compliance to federal and state regulations.

Dear Ms. Barnhill,

Disability Determination for Social Security Administration (DDSSA) respectfully requests to utilize the OPM surrender pool to establish two (2) DDSSA Program Director positions in exchange for surrendering four (4) vacant DDSSA positions. The new positions will receive complete federal funding from the Social Security Administration, as do all DDSSA positions.

DDSSA is responsible for processing disability claims in compliance with Social Security rules and regulations. The DDSSA Program Director is responsible for managing and overseeing staff personnel to ensure program compliance with federal and state regulations, which includes but is not limited to establishing goals, both short- and long-range, the review of operating program policies and procedures for effectiveness and compliance, the integration and implementation of new business processes from other state disability agencies, overseeing the evaluations of program staff, in addition to providing assistance to the agency director.

In my 25+ years with DDSSA, the operations of this agency have always been under the leadership of two employees, classified as DDSSA Program Directors. The same leadership continued after the Arkansas DDSSA was selected to house the largest Extended Service Team in the nation. With one DDSSA Program Director retiring this year and the other retiring shortly thereafter, a total reorganization is needed to meet the ongoing needs of our ever-expanding and changing agency.
