JUSTIFICATION

The Division of Aeronautics currently has five (5) positions. It has numerous forthcoming initiatives, one of which is to enhance aviation education within high schools throughout Arkansas. The responsibilities of the division's requested position will include supporting their Director of Aeronautics with daily operations, acting on behalf of their Director of Aeronautics during agency functions, preparing their agency for the National Association of State Aviation Officials (NASAO) annual conference, attending training and career fairs, as well as providing

administrative program support. This requested position will report directly to their Director of Aeronautics. The agency's existing five (5) positions cannot continue to handle their responsibilities and absorb these forthcoming responsibilities.

RECOMMENDATION

OPM has reviewed this request from ACOM, Division of Aeronautics and **recommends** the establishment of one (1) pool position authorized as A116C, Business Operations Manager. OPM **recommends** the establishment of one (1) pool position as a growth pool position instead of a surrender pool position because position #22093307 is not located within the Division of Aeronautics although the Department of Commerce is voluntarily surrendering this position. The cost for this one (1) growth pool position is approximately \$77,191.80, all from special revenue. The agency guarantees our office that it possesses sufficient funding to support this growth pool position request.
