The Office of Personnel Management (OPM) submits a request for the continuation of previously approved geographic differentials for FY25. The requested differentials for continuation are attached.

The Office of Personnel Management is requesting the continuation of geographic differentials from seven (7) departments. Each department that utilizes the geographic differentials must stipulate the counties where it may be applied to employees and receive approval each biennium. During FY24, these cost an estimated \$1,776,676.62, or an increase of \$886,771 from the previous year.

After review of the requests, the Office of Personnel Management **recommends** the approval of the continuation of these previously approved geographic differentials for FY25.
