Dear Senator Davis and Representative Berry:

The Office of Personnel Management (OPM) submits a request for the continuation of previously approved pool positions for FY25. The requested positions for continuation are attached.

Currently there are forty-nine (49) Growth Pools and one hundred twenty-five (125) Surrender Pool positions from five (5) independent agencies and fourteen (14) departments that are not included in the FY25 appropriation acts. Also included in this request are thirty (30) special language pool positions. Of these thirty (30), twenty-six (26) are located at the Department of Workforce Services and four (4) are located at the Department of Education.

After review of the request, the Office of Personnel Management **recommends** the approval of the continuation of these previously approved pool positions for FY25.
