Dear Senator Davis and Representative Berry:

The Office of Personnel Management (OPM) submits a Reduction in Force (RIF) report from the Department of Military (DOM) for your review. DOM is implementing a RIF due to the closure and non-renewal of federal funding for the Arkansas Youth Challenge program. The list provided by DOM included fifty (50) employees; however, DOM notified our office that two (2) employees have since left the department. Forty-eight (48) employees will be affected by this RIF. The effective date of separation for forty-three (43) employees will be September 30, 2024. The (5) five case managers, who provide the required post residential phase, will remain through the graduation date of June 7, 2025. The National Guard Bureau, who funds the program, has agreed to keep the case managers on through this required time frame.

DOM has requested severance pay for the employees based on their years of service. The estimated cost for the severance payments is \$40,800. Additionally, the affected employees have been placed on the Reduction in Workforce List and will receive special re-employment consideration as established in OPM State Personnel Policy #64. In accordance with the RIF policy #64, any employee with less than 1 year of service is ineligible for severance. Please find the employees impacted attached.

Director Barnhill:

In accordance with OPM Policy 64, Reduction in Workforce (RIF) and Severance Pay, the Arkansas Department of the Military (DOM) is implementing a RIF for fifty (50) positions. The effective date of the RIF for forty-five (45) positions is September 30, 2024. The effective date of the RIF and last day for the five (5) Career Planning and Placement employees will be between approximately September 30, 2024, and June 7, 2024. Some of the five (5) Career Planning and Placement positions will be federally, and state funded through June of 2025 to support the twelve (12) month post residential phase for the Arkansas Youth Challenge class that graduated on June 7, 2024. This RIF is being implemented due to the closing and non-renewal of the seventy-five percent (75%) federal funding for the Arkansas Youth Challenge Program. The inability to recruit and retain essential staff led to the decision of the Department to close the Arkansas Youth Challenge program. The Arkansas Youth Challenge program will continue to receive seventy-five percent (75%) federal funding through September 30, 2024, for an orderly shutdown to include funding for all fifty (50) impacted positions.

Information for the fifty (50) impacted position is attached. DOM requests all fifty (50) impacted positions be immediately added for special reemployment consideration. DOM will pay severance for those eligible employees as indicated in the attachment.
