JUSTIFICATION

ACIC currently trains and audits criminal justice entities utilizing ACIC services. During the August 2013 federal audit by the Federal Bureau of Investigation (FBI), ACIC was advised to audit and train non-criminal justice agencies, including entities having occupations that work with children or the elderly or provide nursing services. The FBI also stated that they were anticipating this practice would become mandatory. ACIC agrees this training/auditing should take place, however the agency currently lacks adequate staffing to provide these functions. Therefore, ACIC is requesting this position in order to comply with upcoming mandates and to properly train and audit these agencies accurately and effectively.

The Arkansas Crime Information Center is requesting to upgrade an existing position through the OPM Swap Pool. The position to be surrendered is a C073C, Administrative Specialist II, Grade C109, and we wish to upgrade it to a D073C, ACIC Field Agent, Grade C117.

The purpose of this position is to assist with training and audits of non-criminal justice agencies. The Arkansas Crime Information Center trains and audits all of the criminal justice agencies in the State that use our system. We have the State divided into 7 areas and we have a field agent assigned to each area to assist with training, support, and audits. Every 3 years, the FBI comes to Arkansas and does a federal audit to verify proper use of the Criminal Justice System. Arkansas law mandates that there are some non-criminal justice occupations that require criminal history checks prior to employment. Those occupations are working with children, nursing, and working with the elderly. During our last audit, which was done in August of 2013, the FBI said that the State should be auditing and training these non-criminal justice agencies. The FBI also said that they were anticipating that in the very near future, it would be mandatory that we audit and train these non-criminal justice agencies. We agree that these agencies should be trained and audited, however, we don't have sufficient personnel to do this. If this position is approved, we will be able to properly train and audit these non-criminal justice agencies, as well as offer faster and more effective technical support.
