JUSTIFICATION

The DDSSA requests the establishment of two surrender pool positions and will relinquish five Administrative Specialist II and one Administrative Specialist III positions. The agency has recently had their federal hiring freeze lifted, allowing DDSSA to hire 77 new adjudicators. Forty-two of these positions have already been filled and the remaining 35 will be filled with a new adjudicator class in June 2014. Under the current agency organizational chart, each DDSSA Section Manager supervises three separate units, amounting to approximately 35 employees. Therefore, the addition of 77 adjudicators will require two new DDSSA Section Managers for supervision purposes.

The minimum qualifications for this classification are a bachelor's degree in social work, psychology, or health administration, or a related area, and five years of experience in social security disability determination, including four years in a supervisory or leadership role. The employees in this classification usually promote from a DDSSA Unit Supervisor, G112C, grade C121. The cost of the positions surrendered is approximately equal to the cost of two employees promoting through the agency organizational structure.

After review of the request, the Office of Personnel Management **recommends** the approval of the establishment of two DDSSA Section Manager positions through the OPM Surrender Pool for FY15. Your consideration of this request is greatly appreciated.

The Federal government recently removed the hiring freeze, which allowed our Agency to hire 77 adjudicators. Due to the extensive training which new adjudicators must complete, the DDSSA new hires were broken into two groups. Stationed at the Sebco Building, DDSSA currently has 30 recently hired adjudicators in a training program and 12 adjudicators that are in the mentoring program. The agency plans to hire the additional 35 adjudicators in June of 2014.

Under the current organizational system, each DDSSA Section Manager supervises three separate Claim Adjudicator Units, which is equivalent to approximately 35 employees. With the Agency hiring an additional 77 adjudicators that need supervision, we are requesting an additional two DDSSA Section Manager positions.

I am hopeful to get this matter on the agenda for the June Personnel Committee Meeting. Although it is not likely, it would be nice to sneak this into the meeting on Wednesday, May 14th.

Your positive review and that of the Legislature would be greatly appreciated. If I can answer any further questions, I am at yours and the committee's disposal to do so.
