The Office of Personnel Management (OPM) submits a request from the Arkansas Department of Health (ADH) for your review.

The Arkansas Department of Health (ADH) is requesting three (3) positions from the position pool established by Arkansas Code Annotated §21-5-225(a)(1). The classifications requested along with the positions being surrendered are listed below:

JUSTIFICATION

ADH's Engineering Section currently has ten Engineer, P.E. positions, grade C124, and three Engineer positions, grade C121. The three Engineer positions were vacated due to employment in the private sector for higher salaries. ADH states that it is essential to attract more eligible applicants who are registered professional engineers and have a minimum of five years of engineering experience. One of the primary duties of these positions is the review of plans and specifications submitted by registered professional engineers for compliance with the Federal Safe Drinking Water Act to ensure public health and safety. Applicants who are registered professional engineers will have the knowledge and experience to easily perform inspections of the facilities with little to no training. Applicants who are registered professional engineers are unlikely to apply for the current engineer positions with the lower grade and pay.

Re: Pool Position Request for the Center for Local Public Health, Engineering Section for three (3) Engineer P.E. positions, Class Code B023C, Grade C124

The Arkansas Department of Health, Center for Local Public Health - Engineering Section is requesting three Pool Positions for three Engineer P.E. positions, Class Code B023C, grade C124. The Engineering Section has three Engineer positions, Class Code B042C, grade C121 that are vacant (positions are 22076785, 22104914 and 22106388). Two of the positions were vacated by Engineers that accepted other employment outside State Government for higher salaries (22076785 and 22104914). Both employees were on track to obtain their Registered Professional Engineer license within the next 6 months and the third position was vacated by an Engineer that retired (22106388).

Currently the Engineering Section has 10 Engineer P.E. positions and 1 Engineer position. The request for the three Engineer P.E. (class code B023C, grade C124) positions is to allow for a greater flexibility during the hiring process to refill these vacant positions. It would allow us to attract more qualified applicants that are Registered Professional Engineers that would not be interested in the lower grade position and pay.

One of the primary job duties of the vacant positions is the review of plans and specifications submitted by Registered Professional Engineers. Applicants that are also Registered Professional Engineers have the experience and knowledge to more readily perform these reviews and inspections of the constructed facilities. These positions are responsible for conducting sanitary survey inspections, engineering plan review, compliance review and determinations, providing technical assistance and training for water systems in the State. Refilling these positions is imperative to meeting the goals of the Engineering Section, which include maintaining primacy of the Federal Safe Drinking Water Act and ensuring safe and plentiful drinking water is delivered to consumers.
