The Office of Personnel Management (OPM) submits a request from the Arkansas Department of Education (ADE) for your review:

The Arkansas Department of Education has requested a special entry rate of $\$ 76,599$, which is between midpoint and maximum of grade C126, for an exceptionally well qualified applicant for the classification Senior Transportation Manager, G039C.

Mr. Jerry Owens's qualifications include a Master of Science in Education as well as thirty-one years of experience in the field of education. The following is a detailed comparison of the minimum qualifications of the classification and Mr. Owen's experience.

## JUSTIFICATION

Statewide, there are zero positions classified as Senior Transportation Manager. There is one position authorized as this classification and it is within the Arkansas Department of Education. Its previous incumbent possessed an annual salary of $\$ 74,309.66$ with approximately twenty-six years of state government experience. The statewide / agency turnover rate for this classification was zero out of one position or $0.00 \%$ within the previous year.

Mr. Owens is currently employed through the Dover School District as its Superintendent of Schools with an annual salary of $\$ 115,000$. He is responsible for supervising the day-to-day operations within the district. Prior to this employment, he was employed through the South Conway County School District as an Assistant Superintendent. His responsibilities within this district included supervising its curriculum structure, transportation operations, and federal programs. His forthcoming ADE position is situated within their Division of Public School Academic Facilities and Transportation and should necessitate supervising its uniform school bus driver training and school bus inspection programs.

Based on salary analysis, the Office of Personnel Management recommends approval of the requested special entry rate of $\$ 76,599$, which is between midpoint and maximum of grade C126, for the classification Senior Transportation Manager, G039C. Approval of this requested special entry rate would result in a $\$ 38,401$ or $33.39 \%$ decrease in the applicant's current annual salary. Your approval of this request is greatly appreciated.
