1 INTERIM STUDY PROPOSAL 2015-139 2 3 REQUESTING THAT THE ARKANSAS LEGISLATIVE COUNCIL AND THE HIGHER 4 EDUCATION SUBCOMMITTEE OF THE ARKANSAS LEGISLATIVE COUNCIL 5 CONDUCT A STUDY OF STUDENT DEBT FROM HIGHER EDUCATION, INCLUDING 6 THE AMOUNT OF STUDENT DEBT, THE IMPACT OF STUDENT DEBT ON 7 GRADUATES, AND POSSIBLE SOLUTIONS TO REDUCING THE STUDENT DEBT 8 BURDEN. 9 10 WHEREAS, the amount of student debt incurred by students attending institutions of higher education has increased substantially over the last 11 12 decade; and 13 14 WHEREAS, the amount of general revenue funding for state-supported institutions of higher education has remained stagnant over the last decade; 15 16 and 17 WHEREAS, the estimated student loan debt for Arkansas students who 18 19 graduated in 2013 is three hundred ninety-seven million seven hundred 20 seventy-eight thousand five hundred dollars (\$397,778,500); and 21 22 WHEREAS, nearly six hundred seventy-five million five hundred forty-six 23 thousand six hundred ten dollars (\$675,546,610) was borrowed by Arkansas 24 students during the 2013-2014 school year; and 25 26 WHEREAS, fifty-five percent (55%) of graduating Arkansas seniors in 27 2013 graduated with student loan debt; and 28 29 WHEREAS, the average student loan debt for an Arkansas student who graduated in 2013 was twenty-five thousand three hundred seventy-five dollars 30 31 (\$25,375); and 32 33 WHEREAS, it is a significant challenge for new graduates who are just 34 beginning a career to carry student loan debt; and 35

1 WHEREAS, student loan debt can make it difficult for young people to 2 fully participate in the economy, as student loan debt can prevent a graduate 3 from obtaining a mortgage or loan; and 4 5 WHEREAS, in many cases, a graduate's first job does not generate enough 6 income to allow a student to repay student loans, 7 8 NOW THEREFORE, 9 BE IT PROPOSED BY THE ARKANSAS LEGISLATIVE COUNCIL OF THE NINETIETH GENERAL 10 ASSEMBLY OF THE STATE OF ARKANSAS: 11 12 THAT the Arkansas Legislative Council and the Higher Education 13 Subcommittee of the Arkansas Legislative Council conduct a study of student debt from higher education, including the amount of student debt, the impact 14 15 of student debt on graduates, and possible solutions to reducing the student 16 debt burden from higher education by creating a profile of students who are 17 currently taking out student loans and identifying the issue of why, including an examination of the amount of loans and the potential impact of 18 those loans on students and student loan default rates. The study may also 19 20 recognize the role that Congress plays in the establishment and rules of 21 federal student loan programs and issue recommendations that can be forwarded 22 to the Arkansas Congressional delegation.
