# Consideration to Approve the Minutes of June 8, 2016

# Revision of Arkansas Statute to Reflect Federal Mandate- See Handout #1

# **Issues Discussed:**

- Revisions to A.C.A § 6-41-103 (2016), Identification of children with specific learning disabilities. Currently, this law speaks of specific learning disability and not the other twelve disability categories which a child could be eligible for under IDEA. Federal law requires that each state have and execute policies and procedures to ensure that all children with disabilities, regardless of severity of their disability who are in need of special education are identified, located, and evaluated. This law is being updated to reflect the federal mandate that would identify all disabilities and not just specific learning disabilities.
- Redlined copy to be prepared and sent to Task Force members so that they can see the specific changes.
- Revisions to be included as part of the recommendations in the final report.

- Professional development and proper placement of children into special education classes.
- Registration of grievances and dispute resolution with the Arkansas Department of Education (ADE)

- ADE is working on Child Find and Identification and professional development/training on RTI to ensure effective communication and coordination of services on the front end.

# **Issues Discussed:**

- Increased funding in the matrix for more special education teachers; including a comprehensive review of salaries.
- Streamline paperwork for special education teachers (without removing critical information).
- Create clearer ways of informing parents of their rights and options in special education.
- Support an incentivized paraprofessional-to-teacher program.
- Strengthen accountability methods of schools in the Child Find process.
- Expand services to rural areas.
- Use restorative discipline practices
- Track student progress to measure impact of RTI practices.
- Fund distributions to districts for special education and meaningful professional development.
