# Senate Ethics Committee Report to the Senate of the Ninety-Third General Assembly

Findings and Recommendations: Sen. Jimmy Hickey, Jr. Petition of Ethical Violation Allegations against Sen. Mark Johnson

# I. Senate Ethics Committee Investigation and Hearing Procedure.

On Wednesday, June 15, 2022, Senator Jimmy Hickey, Jr. filed a petition alleging violations of Senate Ethics Rule 24.03 and Rule 24.06(1)(c) by Senator Mark Johnson. The petition was provided to Senator Mark Johnson, as the respondent to the ethics petition, and to Ms. Ann Cornwell, as the Secretary of the Senate, in accordance with the requirements of Senate Rule 24.09(b).

Senator Kim Hammer, Chair, called a meeting of the Senate Ethics Committee on Thursday, June 23, 2022, at 9:00 a.m., in Room 309 of the State Capitol Building to commence its investigation of the petition and hold a hearing, as required under Senate Rule 24.09(b). Senator Joyce Elliott, Vice-Chair, was unable to attend the first two (2) days of the Committee's proceedings and therefore did not participate in any of the investigation hearings due to her initial absence. Senator Missy Irvin participated in the hearings via Zoom. Senator Mark Johnson, as the Respondent to one of the petitions being taken up by the Committee, was prohibited from serving on the Committee under Senate Rule 24.09(c). Senator David Wallace was selected as Senator Mark Johnson's replacement on the Committee by the Senate Rules Committee, in accordance with Senate Rule 24.09(c)(ii).

Following opening remarks by Senator Hammer on June 22, 2022, regarding the purpose of the meeting and the procedure to be followed, a determination was made by the chair to go into executive session pursuant to Senate Rule 24.08(5). The public was dismissed from the room at that time.

The Committee heard testimony from both Senator Jimmy Hickey, Jr. and Senator Mark Johnson, and asked questions of both parties. In addition, the Committee heard from the following witnesses called by Senator Hickey: Senator Bart Hester, Chair, Senate Efficiency Committee (via Zoom); Ms. Ann Cornwell, Director/Secretary of the Senate; Ms. Leigh Ann Golden-Smith, Senate Constituency Services Office; Ms. Sabrina Lewellen, Deputy Director/Assistant Secretary of the Senate; and Ms. Lesley Rogers, Senate Constituent Services Manager. Both parties and all witnesses were placed under oath. Senator Hickey, Senator Johnson, and members of the Committee asked questions of the witnesses. The Committee heard closing statements and conducted extensive deliberations following the hearing on June 23 and again on Monday, June 27, 2022.

Upon conclusion of the hearing procedure and committee deliberations, the public was allowed to reenter the meeting room, at which time Senator Hammer recognized Senator David Wallace for a motion. Senator Wallace's motion was as follows:

In response to a petition filed with the Senate Ethics Committee, pursuant to Rule 24, on June 15, 2022, by Senator Jimmy Hickey, Jr., the Committee finds that Senator Mark Johnson, signed the name of another senator on the sign-in sheet at the Boys State meeting on June 3, 2022, when Sen. Mark Johnson knew that the senator did not attend the committee meeting. As such, the Committee finds that Senator Mark Johnson violated:

- Senate Rule 24.03, as it relates to failure to comply with statutory provisions of Arkansas Code § 10-2-212 and § 10-2-217; and
- Senate Rule 24.06(1)(c).

As a result of these findings, the committee recommends the following penalties:

- A letter of reprimand be issued to Senator Mark Johnson by the Senate;
- Senator Mark Johnson shall be removed from any committee chair or vicechair positions that he currently holds for the remainder of the 93<sup>rd</sup> General Assembly;
- Senator Mark Johnson shall not be eligible for per diem and mileage for attendance at interim committee meetings for the remainder of the 93<sup>rd</sup> General Assembly;
- Senator Mark Johnson shall be removed from the Senate Ethics Committee for the remainder for the 93<sup>rd</sup> General Assembly; and
- Senator Mark Johnson should not be considered by future President Pro Tempores of the Senate for appointment to serve in the future on Boys State, Girls State, or the Senate Ethics Committee.

I move that these findings and recommendations be adopted by this committee to be included in a written report to be submitted to the President Pro Tempore of the Senate in compliance with Senate Rule 24.10 for consideration by the full Senate; and that the Committee shall meet again to approve the final report.

Senator Wallace's motion was seconded by Sen. Clarke Tucker. Senator Stephanie Flowers then made a substitute motion that in addition to the penalties stated in Senator Wallace's motion, the committee include as a penalty loss of seniority for Senator Mark Johnson in its recommendations to the Senate. The substitute motion did not receive a second, and so the Committee returned to Senator Wallace's original motion, which passed unanimously by voice vote.

The Committee convened again on Tuesday, July 5, 2022, to review the language of a draft report of its findings and recommendations to the Senate. The Committee instructed staff on final revisions to the draft document and voted to authorize Senator Hammer, as chair, to approve the final version of the report with those revisions and to release the report to Senator Jimmy Hickey, Jr., President Pro Tempore of the Senate of the Ninety-Third General Assembly.

This report is submitted to the Senate of the Ninety-Third General Assembly of the State of Arkansas in accordance with Senate Rule 24.10(f):

"Within twenty (20) calendar days of the conclusion of its hearing, the committee shall provide a written copy of its findings and recommendations to the President Pro Tempore for consideration by the full Senate. The report of the committee shall include recommendations regarding penalties to be imposed on the respondent, if any. The findings of the committee are not binding on the Senate, but are merely recommendations."

# **II.** Senate Ethics Committee Findings.

#### A. Findings of Fact.

The Senate Ethics Committee finds:

- Boys State 2022 was held at the State Capitol Building on Friday, June 3, 2022. The Boys State Senate met in the Senate Chamber beginning at 9:00 a.m. and concluded when the presiding officer gaveled out at 11:32 a.m. Senator Mark Johnson and Senator Alan Clark were both members of the Boys State Committee for the Ninety-Third General Assembly. (See, Exhibit B.4., pp.1-3, regarding Senate appointments to Arkansas Boys State 2022)
- At 11:31 a.m. on June 3, 2022, Senator Alan Clark texted Senator Mark Johnson the following request, "Would y'all sign me in? I am at Capitol Hill but running a fever so didn't come over." Senator Mark Johnson responded, "I signed you in." <u>Exhibit B.8.</u>, Text Exchange between Senator Mark Johnson and Senator Clark, June 3, 2022.
- 3. At the end of the chamber proceedings on June 3, 2022, Senator Mark Johnson approached Senate staffer, Ms. Leigh Ann Golden-Smith, and asked for the Senator sign-in sheets. Because she had observed Senator Mark Johnson signing the sheet earlier in the day, Ms. Golden-Smith asked if he had already signed in. "Senator Mark Johnson said he wanted to sign in on behalf of his friend Senator Alan Clark, who he said was not at the Capitol today." Ms. Golden-Smith advised Senator Mark Johnson the sign-in sheets were no longer near the line desk and recommended he speak with Ms. Sabrina Lewellen or Ms. Ann Cornwell. (See, Exhibit B.3., p.4, Written Statement of Ms. Leigh Ann Golden-Smith, June 6, 2022)
- 4. Senator Mark Johnson approached Senate staffer, Ms. Sabrina Lewellen, and asked her if the sheets in her hand were the sign-in sheets and stated that he needed to sign for Senator Clark. Ms. Lewellen replied, "Sir, do you mean Senator Clarke Tucker? He was here earlier and has signed in already." Senator Mark Johnson replied, "No. Alan Clark." (See, <u>Exhibit B.3.</u>, p.3, Written Statement of Ms. Sabrina Lewellen, June 3, 2022)
- 5. Ms. Lewellen responded, "I didn't see him today. Could he have signed in at Audit?" Senator Mark Johnson took the sheet, and Ms. Lewellen observed Senator Mark Johnson sign Senator Alan Clark's name on the sign-in sheet. Senator Mark Johnson then said, "He forgot to sign in." Senator Mark Johnson then walked away. (See, Exhibit B.3., p.3)
- 6. Ms. Lewellen walked up to Senate staffer, Ms. Lesley Rogers, and said, "I did not see Senator Alan Clark today. Did you see him?" Ms. Rogers said, "No, ma'am. I did not." Ms. Lewellen exited the Senate Chamber and handed Senate staffer, Ms. Ann Cornwell, all of the sign-in sheets for Friday, June 3, 2022. Ms. Lewellen advised Ms. Cornwell that Senator Mark Johnson had signed in for Senator Alan Clark, but that none of the Senate staff observed him in the chamber. (See, Exhibit B.3., p.3)
- 7. Ms. Cornwell approached Senator Bart Hester, Senate Efficiency Chair, as he was leaving the chamber to make him aware she just received a sign-in sheet showing a signature for

Senator Alan Clark. However, she was informed that Senator Mark Johnson had signed Senator Alan Clark's name and it did not have the required signature of the acting Boys State Chair.

- 8. After discussion, Senator Bart Hester, directed Ms. Cornwell not to pay Senator Alan Clark for the Boys State proceedings on Friday, June 3, 2022. (*See*, <u>Exhibit B.4.</u>, p.5, Arkansas Senate Sign-In Sheet for Boys State Meeting, June 3, 2022)
- 9. The afternoon of Friday, June 3, 2022, Senator Bart Hester, contacted Senator Jimmy Hickey, Jr., President Pro Tempore of the Senate, regarding this matter. Senator Jimmy Hickey, Jr. concurred with Senator Hester that Senator Alan Clark should not be compensated for the June 3, 2022 meeting. (See, Exhibit B.1., Text Exchange between Sen. Jimmy Hickey, Jr. and Sen. Bart Hester, June 3, 2022)
- 10. On Friday evening, June 3, 2022, Senator Bart Hester advised Senator Jimmy Hickey, Jr. that he called Senator Alan Clark. Senator Alan Clark told Senator Bart Hester he asked Senator Mark Johnson to sign his name. (*See*, Exhibit B.1.)
- 11. On Monday, June 6, 2022, Senator Jimmy Hickey, Jr. contacted Ms. Ann Cornwell and advised her in writing not to pay Senator Alan Clark. (*See*, <u>Exhibit B.2.</u>, Text Exchange between Sen. Jimmy Hickey, Jr. and Ms. Ann Cornwell, June 6, 2022)
- 12. It was stipulated by Senator Alan Clark, and found by the Senate Ethics Committee in relation to the Ethics Violation Petition against Senator Clark, that Senator Clark did not attend the Boys State meeting in the Senate chamber on Friday, June 3, 2022.
- In both his written and oral testimony to the Committee, Senator Mark Johnson stated that he did not ever see Senator Clark at the Boys State meeting on June 3, 2022. (See, Exhibit B.7., Sen. Mark Johnson Statement to Senate Ethics Committee, June 23, 2022.
- 14. Senator Mark Johnson, in his oral and written testimony to the Committee, as well as his text with Senator Clark *(See, Exhibit B.8.)* stated that he signed Senator Alan Clark in for the Boys State meeting on June 3, 2022.
- 15. Due to Senator Hickey's and Senator Hester's directions to Senate staff, Senator Clark was not paid any per diem or mileage by the Senate for the June 3, 2022 Boys State meeting.
- 16. Senator Mark Johnson, like all members of the Senate of the Ninety-Third General Assembly, completed the Ethics Acknowledgement Form, affirming that he "received a copy of the aforementioned Senate Rule and the Senate Code of Ethics. I acknowledge and understand Senate Rule 24.14 and the Senate Code of Ethics. My signature below serves as my annual commitment to uphold the intent of Senate Rule 24.14 and the Senate Code of Ethics." (See, Exhibit B.13., Sen. Mark Johnson's 2022 Ethics Acknowledgment Form)

#### B. Committee Analysis.

In both his written and oral testimony to the Committee, Senator Mark Johnson provided the following explanation for his decision to sign the per diem and mileage sign-in sheet for Senator Alan Clark, even though Senator Clark did not attend the Boys State meeting in the Senate chamber on Friday, June 3, 2022:

Senator Mark Johnson stated, "I presumed that [Sen. Clark] had left the chamber and returned to his apartment during the 35-40 minute time that I was out of the building for my doctor appointment. I also knew that he was supposed to be at a meeting I was scheduled to attend at the Republican Party of Arkansas building at 12 noon, which he did attend later, at approximately 12 noon." <u>Exhibit B.7.</u>, p.1.,Sen. Mark Johnson Statement to Senate Ethics Committee, June 23, 2022. Senator Mark Johnson further stated, "I signed on behalf of Senator Clark, at his specific direction, with the understanding that he had been in attendance, at least in part, for the morning session, and was doing so simply on his behalf." <u>Exhibit B.7.</u>, p.2.

The Committee did not find Senator Mark Johnson's reasoning persuasive for the following reasons:

- Senator Clark texted Senator Mark Johnson on Friday, June 3, 2022, at 11:31 a.m., prior to Senator Mark Johnson signing Senator Clark's name on the sign-in sheet, with the following message: "Would y'all sign me in? I am at Capitol Hill but running a fever so didn't come over." <u>Exhibit B.8.</u> Text Exchange between Sen. Mark Johnson and Sen. Alan Clark, June 3, 2022. This clearly indicated that Senator Alan Clark "didn't come over" for the meeting that day and contradicted Senator Mark Johnson's written and oral testimony before the Committee, where Senator Johnson stated "I signed on behalf of Senator Clark, at his specific direction, with the understanding that he had been in attendance, at least in part, for the morning session". <u>Exhibit B.7.</u>, p.2.
- Senate staffer, Ms. Leigh Ann Golden-Smith, stated in her written and oral testimony to the Committee that when Senator Mark Johnson approached her looking for the sign-in sheets for the June 3 Boys State meeting, "Senator Johnson said he wanted to sign in on behalf of his friend Senator Alan Clark, who he said was not at the Capitol today." <u>Exhibit</u> <u>B.3.</u>, p.4, Email from Ann Cornwell to Sen. Hickey including Senate staff written statements.
- 3. Senate staffer, Ms. Sabrina Lewellen, stated in her written and oral testimony to the Committee that when Senator Mark Johnson approached her for the sign-in sheets for the June 3 Boys State meeting, Senator Mark Johnson said "I need to sign for Sen. Clark." When Ms. Lewellen questioned whether he meant Senator Clarke Tucker, Senator Mark Johnson replied, "No, Alan Clark." Ms. Lewellen testified that she then said to Senator Mark Johnson "something along the lines of 'I didn't see him today. Could he have signed in at Audit?" Following this exchange, Ms. Lewellen testified that Senator Mark Johnson "took the sheet and signed in for Sen. Clark next to his name and said, 'He forgot to sign in.' He then walked away". Exhibit B.3., p.3.

- 4. The Committee found that the Senate staff members' accounts of their interactions with Senator Mark Johnson on June 3, 2022, were substantiated through testimony and exhibits provided to the Committee.
- 5. The three instances set forth above the text message from Senator Clark, and the interactions with the two (2) Senate staffers all occurring prior to Senator Mark Johnson signing Senator Alan Clark's name on the sign-in sheet, provide evidence that Senator Mark Johnson knew that Senator Alan Clark had not attended the meeting for which he was signing him in. Although Senator Mark Johnson stated to Ms. Lewellen that Senator Clark "forgot to sign in", the totality of the evidence presented, including testimony from staff, to the Committee demonstrated that when Senator Mark Johnson signed Senator Alan Clark's name on the sign-in sheet he was aware that Senator Alan Clark had not attended the Boys State meeting that day.

# III. Senate Ethics Committee Recommendations.

As such, it is the recommendation of the Senate Ethics Committee to the Senate of the Ninety-Third General Assembly that the Senate of the Ninety-Third General Assembly of the State of Arkansas concur in and uphold the recommendations of its Senate Ethics Committee, as follows:

#### A. Senate Code of Ethics Violations.

1. The Senate Ethics Committee finds that Senator Mark Johnson violated Senate Rule 24.03, and recommends that the Senate of the Ninety-Third General Assembly of the State of Arkansas find Senator Mark Johnson to be in violation of the Senate's Code of Ethics with regard to Rule 24.03, which reads as follows:

## 24.03 Compliance with Law

Senators shall comply with all constitutional and statutory provisions relating to elected office. Violation of any constitutional or statutory provision shall be grounds for administering penalties as provided in the Code of Ethics. Any penalty imposed by the Senate shall not bar any other civil or criminal proceedings.

The Committee finds and recommends concurrence by the Senate that Rule 24.03 was violated due to Senator Mark Johnson's failure to comply with the following statutory provisions, as evidenced by the findings of fact, stated above, and the exhibits provided as attachments to this report:

a. Arkansas Code §10-2-212, regarding per diem and mileage reimbursement for members of the General Assembly, states at subsection (c), "A member of the General

Assembly shall not file with the House of Representatives or Senate claims for per diem or mileage reimbursement in excess of the maximum amount prescribed by law."

b. Arkansas Code §10-2-217, regarding compensation for members of interim committees and for performance of other interim duties, provides "It is the intent of this section to establish uniform per diem and mileage allowances *for attendance by members* of the General Assembly at meetings of interim committees of the General Assembly and for performing other interim legislative duties as members of the General Assembly where authorized by law." Arkansas Code § 10-2-217(c) (emphasis added). "Other interim legislative duties as authorized by law" under Arkansas Code § 10-2-217(b)(2)(A) includes "Service by members of the General Assembly in connection with the legislative program of Boys State and Girls State, as authorized by § 10-2-121".

<u>Conclusion</u>: Senator Mark Johnson signed Senator Alan Clark's name on the sign in sheet for the June3, 2022 Boys State meeting, which Senator Clark did not attend, thereby indicating that Senator Alan Clark was entitled to collect per diem and mileage reimbursement for which he was not eligible under the law, in violation of Senate Rule 24.03, specifically with regard to the provisions of Arkansas Code § 10-2-212 and § 10-2-217.

2. The Senate Ethics Committee finds that Senator Mark Johnson violated Senate Rule 24.06(1)(c), and recommends that the Senate of the Ninety-Third General Assembly of the State of Arkansas find Senator Mark Johnson to be in violation of the Senate's Code of Ethics with regard to Rule 24.06(1)(c), which reads as follows:

#### 24.06 Prohibited Conduct and Conflicts of Interest

It is the policy of the Senate that a Senator may not have a direct or indirect interest, including financial and other interests, or engage in a business transaction or professional activity, or incur any obligation of any nature that is in substantial conflict with the proper discharge of his or her duties in the public interest.

(1) A Senator shall not knowingly:

[...]

(c) Seek, accept, use, allocate, grant, or award public funds for a purpose other than that approved by law, or make a false statement in connection with a claim, request, or application for compensation, reimbursement or travel allowances from public funds;

The Committee finds and recommends concurrence by the Senate that Senator Clark violated Senate Rule 24.06(1)(c), as evidenced by the findings of fact, stated above, and the exhibits provided as attachments to this report.

<u>Conclusion</u>: By signing Senator Alan Clark's name on the per diem and mileage signin sheet for the Boys State meeting on Friday, June 3, 2022, a meeting that Senator Alan Clark did not attend, and that Senator Mark Johnson knew Senator Alan Clark did not attend, Senator Mark Johnson knowingly made a false statement in connection with a claim, request, or application for reimbursement in violation of Senate Rule 24.06(1)(c).

#### **B.** Penalties.

Under Senate Rule 24.11, the Senate Ethics Committee may recommend the Senate take disciplinary action against a Senator found to be in violation of the Senate's Code of Ethics, and may recommend that the disciplinary action be carried out by imposing one or more of the following penalties:

- (a) Letter of caution;
- (b) Loss of committee assignment(s);
- (c) Loss of leadership assignment(s);
- (d) Loss of seniority;
- (e) Temporary suspension;
- (f) Expulsion;
- (g) Other measures to be determined by the members of the Senate.

The Committee, in its discussing the range of penalties that it may recommend, specifically discussed the possibility of loss of seniority; however, following consultation with legal counsel regarding the issue of validity of a penalty that would extend beyond the Ninety-Third General Assembly, the Committee chose not to include this as a recommendation to the full Senate. The Senate Ethics Committee recommends that upon a determination by the Senate of the Ninety-Third General Assembly that Senator Mark Johnson has violated the Senate Code of Ethics, the Senate impose the following penalties against Senator Mark Johnson:

- 1. A letter of reprimand be issued to Senator Mark Johnson by the Senate;
- 2. Senator Mark Johnson shall be removed from any committee chair or vice-chair positions that he currently holds for the remainder of the 93<sup>rd</sup> General Assembly;

- 4. Senator Mark Johnson shall be removed from the Senate Ethics Committee for the remainder of the 93<sup>rd</sup> General Assembly; and
- 5. Senator Mark Johnson should not be considered by a future President Pro Tempore of the Senate for appointment to serve in the future on Boys State, Girls State, or the Senate Ethics Committee.

- Boys State 2022 was held at the State Capitol Building on Friday, June 3, 2022. The Boys State Senate met in the Senate Chamber from approximately 9:00 a.m. to 11:30 a.m. Senator Mark Johnson and Senator Alan Clark are both members of the Boys State Committee for the 93<sup>rd</sup> General Assembly.
- 2. At the end of the chamber proceedings, Senator Mark Johnson approached Senate staffer Ms. Leigh Ann Golden-Smith and asked for the senator sign-in sheets. Because she had observed him signing the sheet earlier during the day, she asked if he had already signed in. Senator Mark Johnson said he wanted to sign in on behalf of his friend Senator Alan Clark, who he said was not at the Capitol today. Ms. Golden-Smith advised Senator Mark Johnson the sign-in sheets were no longer near the line desk and recommended he speak with Ms. Sabrina Lewellen or Ms. Ann Cornwell.
- 3. Senator Mark Johnson approached Senate staffer Ms. Sabrina Lewellen, and asked her if the sheets in her hand were the sign-in sheets and that he needed to sign for Senator Clark. Ms. Lewellen replied, "Sir, do you mean Senator Clarke Tucker? He was here earlier and has signed in already." Senator Mark Johnson replied, "No. Alan Clark."
- 4. Ms. Lewellen responded, "I didn't see him today. Could he have signed in at Audit?" Senator Mark Johnson took the sheet and Ms. Lewellen observed Senator Mark Johnson sign Senator Alan Clark's name on the sign-in sheet. He then said, "He forgot to sign in." Senator Mark Johnson then walked away.
- 5. Ms. Lewellen walked up to Senate staffer Ms. Lesley Rogers and said, "I did not see Senator Alan Clark today. Did you see him?" Ms. Rogers said, "No ma'am I did not." Ms. Lewellen exited the Senate Chamber and handed Senate staffer Ms. Ann Cornwell all of the sign-in sheets for Friday, June 3, 2022. Ms. Lewellen advised her that Senator Mark Johnson had signed in for Senator Alan Clark, but that none of the Senate staff observed him in the chamber.

Ms. Cornwell approached Senator Bart Hester, Senate Efficiency Chairman, as he was leaving the chamber to make him aware she just received a sign-in sheet showing a signature for Senator Alan Clark. However, she was informed that Senator Mark Johnson had signed Senator Alan Clark's name and it did not have the required signature of the acting Boys State Chairman.
- 7. After discussion, Senate Efficiency Chairman Bart Hester directed Ms. Cornwell not to pay Senator Alan Clark for the Boys State proceedings on Friday.

Senator Mark Johnson came to my office around 11:20 am to pick up "original" petition copy. I asked Ann Cornwell to come into my office at the same time. The original petition copy was actually in her office at the time of Sen Johnson's arrival. I handed the petition to Sen Mark Johnson. He wanted to talk about the matter. The following is a narrative of our conversation. The narrative is the best compilation from my memory that I have in regards to our meeting and is as follows.

When Senator Johnson came in he sat down and began talking. He made a statement that he thought we operated on trust within this body or institution. He stated that he thought this was an immaterial (not sure of exact word he used) type matter. He equated it to being the same as voting for another member in the Senate Chamber. He stated that he had voted for me in the chamber before and that I had possibly voted for him. He stated that voting on legislation by another member would be considered a felony in some states.

He also brought up that he had an opponent in an election this year and that these type things could possibly be used against him and that he may not be able to defend himself when someone states that he has an ethics investigation against him. (I am paraphrasing his comment here). I "assumed" that he was questioning my motive for filing the petition at this point and I told him that everything I had included within the petition was fact based and that the sentence at the end where I stated that I had deep regrets was especially true. I told him everything done from my side was done solely in a pure fashion. Senator Mark Johnson also made the statement that he assumed this was initiated by our staff. I told him that Senator Hester had contacted me and that I was the one who filed the petition. I told him that was in the documentation. He stated that he needed to read it closer.

Senator Mark Johnson asked if this was going to be a dog and pony show or if it was going to be behind closed doors. I told him that the procedure was up to the ethics committee. Senator Johnson started to ask me about the procedures and I asked him to to contact Mr Steve Cook regarding those because I did not want to state anything to him incorrectly.

Senator Johnson was not confrontational and I would consider the meeting cordial considering the circumstances.



Statement to Senate Ethics Committee Senator Mark Johnson June 23, 2022

#### Chairman Hammer and members of the Ethics Committee:

On Friday, June 3, I arrived at the Senate Chamber in the Capitol for the 2022 session of Boys State a few minutes before 9:00 a.m. I entered the Capitol through the south doors, and came up to the third floor on the "Senators Only" elevator. I was present for the opening prayer and pledge, and first official activities.

At or about 9:25, I left the chamber for a 9:30 doctor's appointment on Fair Park Boulevard near I-630. The drive took about five minutes. The appointment was brief and I returned to the Capitol. I left and returned via the "Senators Only" elevator.

I assisted the Boys Staters with their session, and as it adjourned at approximately 11:30 I received a text from Senator Alan Clark. He said he was feeling bad and possibly running a fever, and had gone back to his apartment in the Capitol Hill building. He asked if I would sign him in for the meeting. I knew that he was a member of the Boys State committee, as I had sat with him at the Boys State session at UCA. I presumed that he had left the chamber and returned to his apartment during the 35-40 minute time that I was out of the building for my doctor appointment. I also knew that he was supposed to be at a meeting I was scheduled to attend at the Republican Party of Arkansas building at 12 noon, which he did attend later, at approximately 12 noon.

I then sought out Ms. Leigh Anne Golden-Smith and asked for the sign-in sheet. I had signed in myself earlier that morning. She said that she didn't have the sheet, and suggested that I ask Ms. Sabrina Lewellen. I found Ms. Lewellen near the back left side of the Senate chamber, and told her I needed to sign in for Senator Clark. She said, "do you mean Senator Clarke Tucker – he has already signed in". I told her, "No, for Senator Alan Clark." She asked if Senator Clark had perhaps signed in for Audit Committee meeting that morning. I answered her no, believing that he had been in the Capitol during the Boys State meeting in the Senate chamber, probably during the interval when I had been out for my doctor appointment.

Exhibit B.7 Submitted 6/23/22 by Sen. M. Johnson I then signed in for Senator Clark, and thought nothing more of it than doing a favor requested by a colleague. Later, I saw Senator Clark at the meeting at the RPA office. He was wearing a mask and apologized to those present for wearing it, stating that he had felt ill earlier and didn't want to expose us any more than necessary.

This is the description of my actions related to the matter of this complaint.

In reading the complaint filed by Senator Jimmy Hickey, Jr., I noted that while he referenced an alleged violation of Senate Rule 24.03 "Compliance with Law", he failed to mention the particular constitutional or statutory provision with which I allegedly failed to comply.

It is an accepted tenet of American jurisprudence that anyone accused of breaking a law is to be provided with the citation that he/she is alleged to have broken.

Senator Hickey failed to do so in this case.

Senator Hickey also stated that I violated Senate Rule 24.06 (1)(c). Again, he did not mention specifically which of the stated purposed I had violated, although in context he could have possibly been referring to the fact that I had signed Senator Clark's name "in connection with a claim... from public funds."

As I have explained herein, I signed on behalf of Senator Clark, at his specific direction, with the understanding that he had been in attendance, at least in part, for the morning session, and was doing so simply on his behalf.

I do wish to correct some items in the written record.

Ms. Golden-Smith states in the first paragraph of her written testimony that "Senator Johnson wanted to sign in on behalf his friend Senator Alan Clark, who he said was not at the Capitol today."

I specifically did not say this. While I certainly consider Senator Clark my friend, I absolutely did not mention this to Ms. Golden-Smith. I believe this could be construed to imply some nefarious intention, and is nonetheless irrelevant to this inquiry. In the second paragraph of her written testimony, Ms. Golden-Smith states "I heard Ms. Lewellen ask if Senator Clark had been at Boys State today, and Senator Johnson said no, but that he was going to sign in on his behalf."

While I do not remember Ms. Lewellen asking that specific question, I categorically deny stating "no" in response to whether Senator Clark had been at Boys State on Friday. Further, I state that while I may be been operating under a mistaken assumption that Senator Clark had indeed been in attendance for part of the Friday morning session, I do not recall being asked to confirm his attendance by Ms. Lewellen.

In light of this statement, and due to Senator Hickey's failure to specify the constitutional or statutory citations I violated, I respectfully request that the Committee dismiss this complaint, as it clearly arose solely out of a misunderstanding that I had of Senator Clark's attendance the morning of Friday, June 3, and my only motivation being to accommodate what I sincerely believed was a reasonable request from a colleague who was feeling ill that morning.







The Senate Ethics Committee:

In researching the language on the per diem and mileage request form I have found that the language was used as far back as 2007.

I have no knowledge when that language started being used or who developed it.

February 2, 2015, the Independent Citizens Commission February 2, 2015, recommended and adopted the Senate continue following the U.S. General Services Administration (GSA) rates for per-diem and mileage.

The commission also recommended and adopted no change to the current expense allowance for committee leadership under Ark. Code Ann, Section 10-2-215, the current additional compensation allowance for committee leadership, Subcommittee Chairs and Vice Chairs.

Legislators over 50 miles receive reimbursement for per diem for each day attending committee meetings. Legislators are also reimbursed for one round trip mileage each day for attending meetings but not if they attend consecutive days. If legislators over 50 miles attend a committee meeting within 50 miles of their home, they will be reimbursed the same as legislators under 50 miles.

Reimbursement for legislators over 50 miles attending committee meetings is not taxable unless attending a meeting within 50 miles of their home.

Legislators under 50 miles receive reimbursement for per diem at a lesser rate for each day attending committee meetings. Legislators are also reimbursed for one round trip mileage each day for attending meetings, but not if they attend consecutive days. If legislators under 50 miles attend a meeting over 50 miles from their home they will be reimbursed at the same rate of the outside 50 mile legislators.

Reimbursement for legislators under 50 miles attending committee meetings is taxable and paid monthly.
