

Electric & Hybrid Vehicle Fees

Which states apply special fees on electric and hybrid vehicles?

Lawmakers in 17 states have applied fees on electric or hybrid vehicles to fund state roads. In seven states, fees apply on both electric and hybrid vehicles, and in ten states, fees apply to electric vehicles only. Fees range from \$200 to \$30 per year.
