#### **MEETING SUMMARY**

# VISION 2025 LEGISLATIVE COMMISSION ON THE FUTURE OF HIGHER EDUCATION

Wednesday, September 18, 2013 10:00 A.M. Room 151, State Capitol Little Rock, Arkansas

Senator Joyce Elliott, the Acting Chair of the Vision 2025 Legislative Commission on the Future of Higher Education, called the Commission's first meeting to order at 10:00 a.m.

## **Morning Session**

Senator Elliott, the primary sponsor of Act 1082 of 2013, said she wants these discussions about the future of higher education to be a conversation in which anyone in the state can participate. She stated that the connection between higher education and its importance to the state has been made. She acknowledged this is a big undertaking which has a goal, but not a clear pathway. She advised the Commission to move forward, without settling, and without thinking about barriers.

Senator Elliott announced that Ms. Adrienne Williams would staff the Commission.

Discussion of Purpose, Scope, and Goals of Act 1082 of 2013, and Vision 2025 Commission

Senator Elliott commented that this is deliberately a *legislative* commission, even though it has several gubernatorial appointments. She clarified that, because of term limits, she wanted the legislature to own the commission, so that, if necessary, it would roll over from session to session. She said this Commission has twenty-four (24) members. She noted a few of the appointments are very important to making this more than just a conversation among ourselves. She mentioned the position for "a representative from a historically minority serving university or college in the state." She thought this position was important because those colleges and universities would be a large part of any solutions reached. She said minority voices are not always there as they should be, and made sure that language in the legislation ensured all voices would be heard. Senator Elliott discussed Act 1082 of 2013 in detail so that the charges for the Commission were clear. She covered all sections of the Act, including those on membership and appointments, election of a chair, rules and procedures, funding, and the purpose and responsibilities of the Commission. Senator Elliott stated a progress report was due from the Commission no later than April 30, 2014, with a final report due not later than October 15, 2014. She said the Commission shall cease to exist on January 1, 2017, but might need to continue beyond that date.

Senator Elliott praised the work of former Representative Johnnie Roebuck and the Task Force on Higher Education, Remediation, Retention, and Graduation Rates for which Representative Roebuck had been the Chair. She said the Task Force provided a lot of information on remediation and being prepared for higher education, and that the work in this Commission would build on those findings.

## Presenter & Synopsis:

Mr. Aims McGuinness, Senior Associate, National Center for Higher Education Management (NCHEMS), was recognized. Mr. McGuinness said the focus of NCHEMS is use of information to shape policymaking. He explained that it tries to inform discussions in order to get states to concentrate on the connection between higher education and the future of a state's quality of life, economy, and education attainment of the population. He underscored the importance of the Vision 2025 Commission. He stressed how hard it is, and how important it is, for a state to keep focused on a goal over time in order to make measurable progress. Mr. McGuinness discussed previous efforts in Arkansas, as detailed in the 2011 NCHEMS Report, in a PowerPoint presentation with a handout. He summarized Findings from Data Analysis and Conclusions, Context for Changes: Arkansas Compared to US and SREB States, Progress Over Past Decade, Labor Market Demand, What is Required to Meet the Governor's 2025 Goal, and Next Steps Toward 2025.

### Issues Included in the Discussion:

- alignment of state financial policies and state priorities with regard to providing incentives for degree completion,
- progress of attainment rates for younger students and reasons for the gain,
- populations being left out of any gains,
- consideration and/or influence of the Common Core State Standards Initiative (CCSSI) on the work of the Commission,
- grants provided for certifications beyond high school to identify skill sets,
- challenges presented by *Lake View School District No. 25 v. Huckabee* over the last ten years, resulting in a focus on K-12 over higher education,
- need for more money and targeted money in the system,
- sharing data to see comparisons on a national level,
- driving points about higher education home to the general public,
- use of regional forums,
- need for this to be a conversation about the future of *people* and the *economy*,
- creating a culture of college success, and
- Career Pathways program and the Career Coaches program.

Senator Elliott thanked Mr. McGuinness for the presentation and the Winthrop Rockefeller Foundation for making his appearance possible.

### Presenter & Synopsis:

**Mr. Dave Spence**, President, Southern Regional Education Board (SREB), was recognized. Mr. Spence described the SREB as an organization concerned with issues of pre-K through graduate school throughout sixteen (16) southern states. He stated that things in postsecondary education need to be transformed, but the funding is not there. He noted points had previously been made about the inextricable link between higher education attainment, individual success, the state's economy, and the importance of middle degrees and

certificates. He confirmed the goal is great, and reiterated it will be a challenge for every state to increase degrees and credentials by 4-5% per year. Mr. Spence stated the challenge is very different in a relatively low per capita income state, such as Arkansas. He said the annual *Quality Counts* report ranks states on a set of indicators in the areas of: finance, transitions and alignment, K-12 achievement, the chance for success, standards assessments and accountability, and the teaching profession. He noted Arkansas ranked fifth in the latest report. He said the SREB looks at where the achievement index is ranked higher than the chance for success index. He commented that Arkansas is making changes and preparing students who are going to become richer and more educated parents. He referred to the handout, *No Time To Waste*, and detailed recommendations for increasing the numbers of certificates and degrees in four action areas: 1) Goals and Expectations, 2) Accountability and Shared Responsibility, 3) Measures, and, 4) Financing and Educational Policies and Practices. He warned the extent of the college readiness problem has been underestimated. He discussed the role higher education needs to play regarding the CCSSI and the Partnership Assessment of Readiness of College and Careers (PARCC) assessments.

- attend a November 20<sup>th</sup> meeting in which several existing and new entities will address remediation,
- infuse funds for programs, such as the Career Coaches program, into the budget during the Fiscal Session,
- take advantage of one-year certificates of value as one of the fastest ways to grow the per capita income within the state by building toward a change in the funding formula for two-year schools,
- hear testimonials on creating the workforce to grow advanced manufacturing jobs in the South,
- discuss entrepreneurship and how it relates to college graduation,
- get the perspective of higher education on the CCSSI,
- have civilian groups in different regions of the state present their perspective, and
- look at needs-based scholarships and availability of scholarships in general.
