27	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

29	SECTION 1. Arkansas Code Title 6, Chapter 60, Subchapter 1, is amended
30	to add an additional section to read as follows:
31	6-60-113. Homeless and foster student liaison.
32	(a) As used in this section, "institution of higher education" means
33	an institution of higher education that is a:
34	(1) State-supported two-year or four-year college or university;
35	<u>or</u>

1	(2) Private, nonprofit two-year or four-year college or
2	university that is eligible to receive Title IV federal student aid funds
3	with its primary headquarters located in Arkansas.
4	(b) An institution of higher education shall designate a member of the
5	staff of the institution of higher education to serve as the homeless and
6	foster student liaison.
7	(c) An individual designated as a homeless and foster student liaison
8	under subsection (b) of this section shall:
9	(1) Inform students of the institution of higher education
10	about:
11	(A) Financial aid; and
12	(B) Other means of financial assistance available to the
13	students of the institution of higher education; and
14	(2) Assist students of the institution of higher education in
15	applying for and receiving federal and state financial aid and other
16	available services.
17	(d) An individual designated as a homeless and foster student liaison
18	under subsection (b) of this section shall be selected by an institution of
19	higher education from amongst current staff members of the institution of
20	higher education.
