17	TO CREATE A PILOT PROGRAM REGARDING
18	INTRASTATE DISTRICT EXCHANGE EXPERIENCES.

21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22	
23	SECTION 1. Arkansas Code Title 6, Chapter 16, Subchapter 1, is amended
24	to add an additional section to read as follows:
25	6-16-151. Intrastate district exchange experience.
26	(a) The purpose of this section is to create opportunities for public
27	school and open-enrollment public charter school students and teachers to
28	study a variety of topics surrounding school and community life in other
29	communities through a two-year intrastate district exchange experience.
30	(b) A public school and an open-enrollment public charter school may
31	offer to public school and open-enrollment public charter school students and
32	teachers the opportunity to participate in an intrastate district exchange
33	experience under this section.
34	(c) An intrastate district exchange experience under this section
35	shall:
36	(1) Last for at least one (1) week but no longer than two (2)

1	weeks;
2	(2) Include without limitation studies that cover the following
3	topics:
4	(A) Academics;
5	(B) Culture;
6	(C) History;
7	(D) Social conditions; and
8	(E) Economic conditions;
9	(3) Be scheduled in accordance with agreements made by the
10	participating public schools and open-enrollment public charter schools; and
11	(4) Ensure that participating public schools and open-enrollment
12	public charter schools develop a course of study that:
13	(A) Incorporates aspects of the community in which the
14	participating public schools and open-enrollment public charter schools are
15	<u>located; and</u>
16	(B) Is approved by the Department of Education.
17	(d) A public school student who participates in an intrastate district
18	exchange experience under this section shall:
19	(1)(A) Complete and submit a capstone project at the conclusion
20	of the intrastate district exchange experience.
21	(2) Not be considered absent during the days in which the
22	student is participating in the intrastate district exchange experience;
23	(3) Earn credit for his or her participation in the intrastate
24	district exchange experience under this section; and
25	(4) Obtain permission from his or her parent or legal guardian
26	to participate in the intrastate district exchange experience.
27	(e) A public school or an open-enrollment public charter school shall
28	be responsible for the payment of a substitute when a public school or open-
29	enrollment public charter school teacher is participating in an intrastate
30	district exchange experience under this section.
31	(f) A public school or open-enrollment public charter school student
32	or teacher participating in an intrastate district exchange experience under
33	this section shall be housed in public school district-approved facilities
34	during the course of the intrastate district exchange experience.
35	(g) A private entity or an individual may participate in the funding
36	of intrastate district exchange experiences under this section, including

1	without limitation by making in-kind donations.
2	(h)(l) The department shall promulgate rules necessary to implement
3	this section.
4	(2)(A) When adopting the initial rules to implement this
5	section, the final rules shall be filed with the Secretary of State for
6	adoption under § 25-15-204(f):
7	(i) On or before January 1, 2018; or
8	(ii) If approval under § 10-3-309 has not occurred
9	by January 1, 2018, as soon as practicable after approval under § 10-3-309.
10	(B) The department shall file the proposed rule with the
11	Legislative Council under § 10-3-309(c) sufficiently in advance of January 1,
12	2020, so that the Legislative Council may consider the rule for approval
13	before January 1, 2020.
