28	SECTION 1. Arkansas Code § 23-115-801(a)(3), concerning the percentage
29	of net proceeds from a lottery under the Arkansas Scholarship Lottery Act, is
30	amended to read as follows:
31	(3) The percentage of lottery proceeds determined by the office
32	to be net proceeds shall equal an amount determined by the office to maximize
33	net proceeds for scholarships that is not less than the following:
34	(A) For the fiscal year ending June 30, 2022, twenty
35	percent (20%) of lottery proceeds;

1	(B) For the fiscal year ending June 30, 2023, twenty-one
2	percent (21%) of lottery proceeds;
3	(C) For the fiscal year ending June 30, 2024, twenty-two
4	percent (22%) of lottery proceeds;
5	(D) For the fiscal year ending June 30, 2025, twenty-three
6	percent (23%) of lottery proceeds;
7	(E) For the fiscal year ending June 30, 2026, twenty-four
8	percent (24%) of lottery proceeds; and
9	(F) For the fiscal year ending June 30, 2027, and each
10	fiscal year thereafter, twenty-five percent (25%) of lottery proceeds.
