Discussion of Issues Related to Teacher Salaries

#### Presenter:

Ms. Lori Bowen, Legislative Analyst, Policy Analysis and Research Section, Bureau of Legislative Research, was recognized. Ms. Bowen reviewed portions of the Adequacy Study that relate to teacher salaries. She stated the General Assembly is required to review the average teacher salary in the State of Arkansas in comparison to average teacher salaries in surrounding states and Southern Regional Education Board (SREB) member states; and to evaluate whether any changes are necessary as a result of the review. She said this includes comparing teacher salaries as adjusted by a cost-of-living index or a comparative wage index; reviewing the minimum teacher compensation salary schedule; and reviewing the current status of salary disparity among districts across the state. She presented responses to five (5) questions prepared in partial fulfillment of the Adequacy Study requirements. Ms. Bowen walked the Committees through the in-depth report, detailing data contained in charts, graphs, and maps. Her discussion included Teacher Salary Comparison Among SREB and Surrounding States; Teacher Salary Disparity Within Arkansas; State Mandated Teacher Salary Schedules – 2017-18; Local District Salary Schedules – 2017-18; Average Pay for Other Professions; and Adequacy Surveys – Comments on Compensation, including those from principals during on-site visits.

- whether there is a correlation between teachers' salaries and student achievement,
- > financial impact on teachers after retirement,
- > data on how school districts spend money,
- whether there is a correlation between administrative salaries and student achievement,
- > districts spending more money than they are receiving through the Matrix,
- impact of cost-of-living and geography on salary, and
- effect of the use of substitute teachers on salary.

#### Presenter:

Ms. Julie Holt, Legislative Analyst, Policy Analysis and Research Section, Bureau of Legislative Research, was recognized. Ms. Holt initially presented a historical perspective of curriculum requirements and the Standards for Accreditation over the last four decades. She included Opposite Philosophies and Taylorism v Dewey in Arkansas. Utilizing a PowerPoint presentation, she continued the discussion on effects of the implementation of the revised Rules Governing Standards for Accreditation, and included Arkansas Academic Standards; Graduation Requirements/Smart Core; Advanced Educational Courses; Computer Science Requirements; and Student-Focused Learning.
