Continued Discussion of Adequacy Issues and Potential Recommendations for the 2018 Adequacy Report

Presenter:

Ms. Nell Smith, Administrator, Policy Analysis and Research Section, Bureau of Legislative Research, was recognized. Ms. Smith reviewed the materials provided to Committee members to inform their decision-making process. She drew their attention to the Bureau Brief, *Adequacy Report Public Comment*, and explained its contents. She noted any additional comments received on the general comment link will be passed along in the October meeting. She reminded members of their request for a survey of digital learning providers; she said results will be provided in the October meeting. She stated a draft of the Adequacy Report must be published October 18, with the final report due on November 1, 2018. Ms. Smith revisited statutory requirements; and noted documents included as handouts.
