**The Honorable John Hutchison**, State Representative, District 52, was recognized, and requested that Interim Study Proposal (ISP) 2013-160 be adopted for interim study by the House Interim Committee on Education.

The Honorable Charles L. Armstrong, State Representative, District 30, was recognized, and made a motion to adopt ISP 2013-160 for study.

Reports from Members Who Attended Recent Meetings Concerning Public or Higher Education

### Presenters & Synopses:

**The Honorable Mark Lowery**, State Representative, District 39, was recognized. Representative Lowery said that he, Representative Charlotte Vining Douglas, and Representative Charles Armstrong attended a conference sponsored by the Council of State Governments (CSG) in Washington DC last June. He said topics included higher education reforms going on in states, and mentioned, specifically, the dramatic shift in the way Tennessee is handling remediation. He noted that Tennessee has also moved to a system of outcomes-based funding. Representative Lowery remarked that moving to such a model not only increases competition, but increases attention to goal attainment.

**The Honorable Charles L. Armstrong**, State Representative, District 30, was recognized. Representative Armstrong commented that the problem of remediation in higher education starts in K-12, and, until there is a fix in K-12, the need for remediation will continue. He mentioned having attended a meeting yesterday at the University of Arkansas at Pine Bluff (UAPB). He said UAPB is addressing this problem now in admissions. Representative Armstrong also mentioned that emphasis needs to be put back on career education.

**The Honorable Charlotte Vining Douglas**, State Representative, District 75, was recognized. Representative Douglas brought up the subject of massive open online courses (MOOCs), and said this is an issue that should be reviewed.

Update on the Activities of the Quality Digital Learning Study Committee

## Presenter & Synopsis:

**Dr. Ed Franklin**, Chair, Quality Digital Learning Study Committee, was recognized. Dr. Franklin said that knowledge about the new technology is of prime importance in a changing world. As part of his presentation, he showed a YouTube video, "Did you know? SHIFT happens!" He cited examples of the use of technology within education and how it's changing education. He commented that with so much information available, technology is allowing the role of teacher to shift from the "sage on the stage" to a supporter of learning. He mentioned courses being developed all over the United States for use by K-12 and colleges and described *flip teaching*, a new method of instruction. He stated the reality is that without connectivity, without Broadband, none of this would be possible. He said the challenge for the Quality Digital Learning Study Committee is to examine Broadband connectivity in K-12 schools, to identify current assets and capabilities, and to develop a plan to use assets and resources in the best way to meet needs of students in preparing them for the workforce of the future. Dr. Franklin discussed various committees and groups, with memberships composed of representatives from

business and industry, who will help in developing a plan. He said the study is in its early stages, with a final plan to move education forward in the K-12 system to be delivered by December 2013.

- accommodations for testing and assessments,
- stepping back into a traditional workplace having been educated with the new technology,
- setting up systems that are expandable to accommodate increased capacity,
- delivery of the final report pursuant to Section 2 of Act 1280 of 2013,
- looking at all technologies as part of the review,
- responses from school districts to the Arkansas Department of Education (ADE) survey,
- agreeing on the data with which to begin the study,
- speed of connectivity and access to technology in other countries,
- target measure for connectivity used by other states, and
- integrating knowledge of grants with educational needs.
