## Action Item:

**The Honorable Joyce Elliott**, State Senator, District 31, and Vice Chair, Senate Interim Committee on Education, was recognized, and made a motion regarding making the Alternative Pathway to Graduation Program, discussed at the Monday, July 14, 2014 meeting, a pilot program for SY2014-15. She stated

"...they made this great presentation to us about the alternative diploma...and we were really impressed with that, and we did everything except make the motion to recommend the Program to the State Board for a pilot...and so, what I wanted us to do today is to go ahead and make the motion, rather than just let it be assumed because we didn't take an official action...we just kind of left the impression that we all loved it and that was that."

"So, Mr. Chair, I move that we recommend the pilot for the alternative diploma to the Board of Education for implementation at a time that the Board is prepared to do it."

Pursuant to the motion by Senator Elliott, and without objection, the motion was carried.

Reports from Members Who Attended Recent Meetings Concerning Public or Higher Education

Senator Elliott discussed recent education meetings held at the Southern Legislative Conference (SLC). She said one of the best presentations was from Toyota on innovations in the classroom. Senator Elliott also commented on the Imagication Institute and bringing people together to think about imagination in education.

Presentation by the 2014 Arkansas Teacher of the Year

## **Presenter & Synopsis**:

Mr. Jonathan Crossley, English Language Arts Teacher, Palestine-Wheatley High School, Palestine-Wheatley School District, was recognized. Mr. Crossley gave a PowerPoint presentation on distributed leadership, letting teachers take on leadership roles to contribute more effectively to key initiatives within schools, districts, and the state. He discussed teacher turnover, the high cost of teacher attrition, the effect of leadership opportunities, and the goals and guiding principles of teacher leadership. He described the South Carolina Teaching Fellows Program, a program funded by the South Carolina General Assembly, as a model to help remedy the shortage of excellent teachers and funding. He said the Teaching Fellows Program encourages teachers to have a voice, to give what they have, to be knowledgeable, and to change things that they don't like. Mr. Crossley asked the Committees for their thoughts about the leadership model and their views about systematic leadership in education.

#### Issues Included in the Discussion:

- o defining leadership opportunities and roles to be taken,
- o participating universities and colleges in the South Carolina Teaching Fellows Program,
- o looking at any profession as a matter of the commitment of the individual, and not as a matter of age,
- o exploring laws in place that might be a roadblock to change,
- o expectations of teachers, including that of time,

- o criteria for acceptance into the Teaching Fellows Program,
- o the "plucking the wings" syndrome,
- o similarity of the Teaching Fellows Program to the process for National Board Certification,

Preliminary Discussion of the Draft Report Mandated by Act 107 of 2013

## Presenter:

**The Honorable Linda Chesterfield**, State Senator, District 30, was recognized. Senator Chesterfield introduced the preliminary report, *A Study of the Readiness of Public Schools in Response to Acts of Violence (Anti-Bullying)*. She noted that research was currently being done on positive behavioral models for managing a classroom and would be added to the report.

## Presenter & Synopsis:

**Dr. Mandy Gillip**, Legislative Analyst, Bureau of Legislative Research, was recognized. Dr. Gillip stated this report is being created to highlight the statutes and the available practices and policies of public schools in the State of Arkansas as they pertain to school violence and to incidences of bullying on school grounds. She walked the Committees through the report, discussing current statutes; status of the Safe Schools Committee; cyberbullying laws and dealing with them in schools as part of the wider disciplinary problem; partners working with schools and school districts to create Continuity of Operations Programs (COOPs); and services provided by the Arkansas Department of Information Services (DIS). Dr. Gillip provided statistics on violence and bullying in Arkansas schools and included a comparison with surrounding states. She stated this is a report that gives a general idea of what it looks like to be prepared both in the State of Arkansas and in other states for an unforeseen violent act on campus including, but not limited to, acts of bullying.

#### Issues Included in the Discussion:

- collecting statistics on all types of interactions where bullying can occur,
- balancing safety and liberty when dealing with this issue,
- correlation between bullying and an extreme outcome,
- ALICE (Alert, Lockdown, Inform, Counter, and Evacuate) Training Institute,
- clarification of numbers in chart on page 9 of the draft report,
- expanding the report to identify the number of complaints of attacks by students reported by teachers that turned out to be legitimate,
- expanding the report to include the effects of the presence of school resource officers, and
- parental and community involvement.

Ms. Reinhart briefly explained changes and adjustments to the rules made in response to questions that had been raised during its original presentation to the Committees in a meeting on Tuesday, May 13, 2014. She said the rule would become effective September 1.

Discussion of Proposed National Science Standards

## **Presenter & Synopsis**:

**Dr. Debbie Jones**, Assistant Commissioner of Learning Services, Arkansas Department of Education, was recognized. Dr. Jones stated that the Next Generation Science Standards (NGSS) are necessary at this time because 60% of U.S. jobs are predicted to require some form of post-secondary education by the end of the decade; the National Science Foundation (NSF) reports that there are currently up to three (3) million unfilled positions in STEM (Science, Technology, Engineering, and Mathematics) areas; and the United States Department of Commerce (DOC) shows that in the past ten years STEM jobs grew at three times the rate of non-STEM jobs and that's a trend that's likely to continue. Dr. Jones related personal stories about her children and their experiences in this area. Dr. Jones provided highlights of conceptual shifts in NGSS, and discussed the standards with regard to collaborative partners, writing, content, practice, and arrangement, and noted that the standards are internationally benchmarked. Dr. Jones included commentary on the alignment of the NGSS with the Common Core State Standards.

- ≈ timing and tests for NGSS,
- ≈ implementation of NGSS,
- ≈ funding for NGSS,

- ≈ formal adoption of NGSS.

She said, while Arkansas gets good grades for accumulation of knowledge, two things that would be enhanced by NGSS in Arkansas are scientific inquiry and methodology. She commented on ways for Arkansas to get better than a B rating. Senator Elliott stated her major concern is to be able to compete in the world.
