Update on the Activities of the Arkansas Advanced Initiative for Math and Science, Inc.

Presenter:

Dr. Ken James, President, Arkansas Advanced Initiative for Math and Science, Inc., was recognized. Dr. James highlighted the success of the Arkansas Advanced Initiative for Math and Science, Inc. (AAIMS) program since its inception, as well as discussing the Spring 2015 results. He said AAIMS will work with fifty-five (55) schools in 2015-2016. He noted five (5) new schools joined Cohort 7 this past fall, and six (6) to eight (8) new schools are expected to join in the fall of 2016. Utilizing a PowerPoint presentation, he discussed the increase in qualifying scores and the increase in students taking a Math, Science, and English (MSE) Advanced Placement (AP) exam while in the program for Cohorts 4 (9 schools), 5 (7 schools), and 6 (8 schools). He additionally discussed state rankings for increases in passing scores and in qualifying scores from 2008 – 2015. His presentation included pie charts illustrating the increase in the number of students taking AP math, science, and English classes, the increase in the number of qualifying scores on AP math, science, and English exams, and the increase in minority students in the state taking AP courses and achieving qualifying scores. Dr. James said that AAIMS is making a difference in the state by changing expectations and achievement.

Mr. Johnny Key, Commissioner, Arkansas Department of Education, was recognized. Mr. Key introduced discussions concerning the four (4) school districts under state control. The content of the discussions included school-specific issues relating to Community Advisory Boards (CAB), new appointments to CABs, fiscal status, state board action(s), and meeting improvement plan objectives, as well as updates on litigation issues, academic issues, and operational and fiscal issues. Issues Included in the Discussion:

Helena-West Helena School District:

- definition of "material" as it relates to audit findings,
- criteria used to make distress determination,
- percentage required for ending school district balances in Arkansas,
- having the General Assembly legislatively establish ending balance requirements,
- movement in student scores while under state control,
- reworking the audit findings component of the definition of *fiscal distress*,
- repeated audit findings while under state control,
- following business procedures during state takeover,
- inability to waive fair dismissal as one of the tools available to turn a district around, and
- assistance from the Office of Intensive Support.

Pulaski County Special School District (PCSSD):

- o resolving fiscal distress and meeting the desegregation settlement agreement,
- o practices and procedures which are currently not in place and causing PCSSD to remain in fiscal distress,
- Objective 37 (identify cost reduction possibilities in the event state desegregation funding is eliminated) is the only objective in the fiscal distress plan that has not been accomplished,
- o detachment of Jacksonville and a millage election,
- o understanding how is the state not complicit in allowing action to happen that would help keep PCSSD in fiscal distress by agreeing to the action of detaching Jacksonville School District,
- o putting monetary impact on audit violations; addressing the monetary impact on a school district in the definition of fiscal distress,
- o ability of PCSSD to function with loss of \$20.8 million per year figure in Objective 37, and \$40 million per year loss resulting from detachment of Jacksonville School District,
- o reducing the operating expenses equal to the loss of revenue,
- o meeting the state mandate to detach Jacksonville, resulting in a declining fund balance, and
- o addressing facilities for students in an equitable way.

Little Rock School District (LRSD):

- whether improvements were realized in student achievement following meetings between the Office of Intensive Support and principals and school improvement specialists (SISs) in three (3) high schools,
- importance of having a broad-based, community-based school district,
- annexing the LRSD with Cabot, Bryant, and Benton,
- effect on the superintendent's effectiveness if the eStem Public Charter School proposal comes to fruition, putting changes in place and making the funding work for the LRSD going forward; millage increase for the LRSD,
- allowing the LRSD to name its own SISs,
- necessity of having individual improvement plans for each of the three (3) high schools in academic distress,
- statutory obligation regarding threshold needed to be reached in order to be removed from the academic distress designation, and
- impact of proposed new middle school in West Little Rock and school attendance zones on race.

Dollarway School District:

- Arkansas Department of Education (ADE) providing support to the district for transcript audits for senior students,
- ≡ issues in the district going well beyond academic distress,
