Discussion of Issues Related to Teacher Salaries

#### Presenter:

**Mr. Richard Wilson**, Assistant Director, Research Services, Bureau of Legislative Research (BLR), was recognized. Mr. Wilson stated he would discuss Part B of the Teacher Salary Report and address questions 4, 5, and 6. He said remaining questions (*1, 2, and 3*) would be addressed in Part A at a later date, following receipt of additional data. Utilizing maps and charts, Mr. Wilson discussed Teacher Salary Disparity within Arkansas, including 2014-15 Minimum Salary Rank by School District and 2014-15 Average Salary Rank by School District. Mr. Wilson provided data comparing teacher salaries in Arkansas with salaries in other professions having similar educational requirements; and discussed instructional areas which have the largest number of

teachers teaching out of area in Arkansas. Mr. Wilson noted that a table in the Appendix, *Additional Comments on Compensation*, was created from replies to question #6 on the teacher survey which gave teachers the opportunity to openly comment on concerns regarding teacher compensation. The survey was distributed as part of the Adequacy Study's 73 site visits.

- comparing test scores within quartiles, and
- connection between teacher salary and student achievement.

Discussion of Issues Related to Teacher Recruitment and Retention

### Presenter:

**Dr. Ginny Blankenship**, Legislative Analyst, Policy Analysis and Research Section, Bureau of Legislative Research, was recognized. Dr. Blankenship stated this is the first time that the BLR has done a report on teacher recruitment and retention in almost ten (10) years. While not required as part of the Arkansas Supreme Court's mandate to do an Adequacy Study, Dr. Blankenship thought the issue was important to revisit. She stated the Report includes analysis of data from the Arkansas Department of Education (ADE) and Arkansas Department of Higher Education (ADHE). Utilizing charts and graphs, Dr. Blankenship discussed the supply, distribution, and attrition of public school teachers in all Arkansas public schools districts and public charter schools. She also discussed a BLR analysis of district-level teacher retention, a BLR survey of superintendent, principal, and teacher perceptions, and policies and programs to address teacher recruitment and retention. In the latter, Dr. Blankenship touched on salary and other financial incentives, loan forgiveness or scholarship programs, discontinued programs, and alternative pathways to the classroom. She commented on an informational handout, *Appendix: Teacher Survey Responses*, prepared for distribution to members.

- recommendations of Legislative Task Force on the Best Practices for Special Education Task Force pertinent to the critical shortage of special education teachers,
