Remarks by the Chair

Representative Cozart recognized the incoming committee members and members-elect present at the meeting and requested that they introduce themselves and the district they represent.

Discussion of Draft Adequacy Report and Related Issues

Representative Cozart called members' attention to the November 1, 2016 letter from the Senate Interim Committee on Education to Senator Jonathan Dismang, President Pro Tempore of the Senate and Representative Jeremy Gillam, Speaker of the House, containing the Senate Committee's recommendations concerning Adequacy. He requested members review the letter and ask any questions pertinent to the document.

#### Issues Included in the Discussion:

- clarification of line items in the Matrix that will either increase or remain flat in FY17 FY19,
- clarification of those items contained in Exhibit A (Additional NSL, SPED Catastrophic, and Supplemental Transportation) concerning potential funding increases from one fiscal year to the next, and
- whether concurrence by the House Education Committee to the Senate Committee's Adequacy Report satisfies the legal obligations pertaining to educational adequacy.

A discussion ensued about the appropriate parliamentary procedure to follow. Representative Cozart stated that any vote taken by the Committee would be a new vote on a new proposal, not another vote on any proposal previously considered by the Committee.

**The Honorable Jeremy Gillam**, Speaker of the House, and State Representative, District 45, was recognized. Representative Gillam recounted the discussion at the November 1, 2016 meeting of the Senate Education Committee regarding the dedication of any proposed increase in Professional Development (PD) Categorical Funding for the state-wide implementation of professional learning communities (PLCs). He noted that the earmarking of these funds was not included in the Senate Committee's Adequacy Report. Representative Gillam requested that this stipulation be included in the Adequacy Report adopted by the House Education Committee.

#### Relevant Actions:

**The Honorable Mark Lowery**, State Representative, District 39, was recognized. Representative Lowery moved that the House Interim Committee on Education adopt the Adequacy Recommendations contained in the Senate Interim Committee's Adequacy Report, with the stipulation that any proposed increase in Professional Development Categorical Funding be set aside for the state-wide implementation of professional learning communities.

The motion was seconded by Representative Charlotte Vining Douglas.

#### Pursuant to the motion by Representative Lowery, the motion was carried on a voice vote.

**The Honorable John W. Walker**, State Representative, District 34, was recognized, and made a motion for a roll call. The motion was seconded by Representative Charles L. Armstrong.
