# Presenter & Synopsis:

Ms. Nell Smith, Administrator, Policy Analysis and Research Section, Bureau of Legislative Research, was recognized. Ms. Smith provided information about how the Affordable Care Act will affect public school employees' health insurance. She described the major components of the Affordable Care Act, including health benefits exchange, employer requirements, impact of employer requirements on districts, individual mandates, and impact of individual mandates on district employees. Ms. Smith provided an example of how an exchange and premium credits would figure into an employee's decision

making, and included the premium cost for the state plan and the premium cost for coverage through an exchange with premium credits. She described contributing variables that make projections of enrollment numbers a challenge.

Association (AEA) to a series of spreadsheets received by Subcommittee members at the last meeting. He said that in working with the information, the AEA prepared a memorandum with certain findings of facts to share with the Subcommittees. He said the spreadsheets only include data from school districts and do not include charter schools or educational service cooperatives. Mr. Nagel briefly reviewed points in the memorandum.

#### Issues Discussed:

- o AEA continuing to work on millage rates,
- o school districts employing more/less employees than provided for in the Matrix,
- o in terms of Adequacy, professional judgment panels had far higher numbers of school employees for the needs of Arkansas students than Odden and Picus,
- o reevaluating the Matrix, and
- o making additional revisions to the spreadsheets.
