## Remarks by the Co-Chairs:

Senator Key welcomed the Members-Elect to the meeting and asked that they introduce themselves.

Representative Randy Stewart, the House Co-Chair of the Joint Subcommittee on Public School Employee Health Insurance of the House and Senate Interim Committees on Education, commented that the Arkansas Supreme Court's November 29, 2012, ruling in the *Kimbrell v. McCleskey* case regarding the uniform rate of tax (URT) may have some impact on funding and could be a topic for a future meeting.

Discussion of the Issues Related to Public School Employee Health Insurance from the Employee Perspective

# Presenter & Synopsis:

Ms. Shelley Branscum, Teacher, Mountain View School District, was recognized. Ms. Branscum shared background information on what had prompted her involvement in the issue of increasing premiums costs and on why public school employees are paying so much more than state employees for the same health insurance coverage. She said the issue is not only about teachers, but about all the people who work in the public schools, including cafeteria workers, bus drivers, teacher's aides, secretaries, superintendents, and principals, all of whom have the same coverage. She commented on the 4,189 signatures, to date, on petitions she has received in support of her efforts, and on a map indicating areas of Arkansas from which the petitions had been received. In her presentation, Ms. Branscum discussed what she has learned during her investigation, and provided a list of requests for action on this issue.

Continued Review of Issues Related to Public School Employee Health Insurance

### Presenter & Synopsis:

**Mr. Jason Lee**, Executive Director, Employee Benefits Division, Department of Finance and Administration, was recognized, and discussed administration costs paid on state employee and public school employee plans.

### Issues Discussed:

- base administration costs,
- · administration fees assessed on rates,

- additional funding stream for state employees received through employer's Federal Insurance Contributions Act (FICA) savings due to pre-tax deductions of employees' premiums,
- description of FICA savings on pre-tax withholding,
- effect of uniform cafeteria plan for state employees; public school districts have own cafeteria plan and own pre-tax premiums,
- availability of a comparison of benefits packages for state employees and public school employees,
- cafeteria plans structured at the employer-designated level,
- unintended consequences resulting from a common cafeteria plan vs. a private plan,
- public funds received for the purpose of offsetting health insurance premiums have to be used for the plan designated by the board,
- potential impact of Medicaid expansion on public school employees, and
- continually increasing disparity between state employee and public school employee plans.

Mr. Rich Nagel, Executive Director, Arkansas Education Association, was recognized. Mr. Nagel provided a brief historical perspective on the health insurance issue, and then stated that public school employees and state employees in Arkansas do not fare as well with regard to employer contributions for health insurance as those employees in other states. He addressed the three (3) main problems this year with the Public School Employees Health Insurance Program: insufficient overall funding, a different distribution of the state and plan contributions by the EBD, and the inadequate contribution of local school districts. With regard to the latter, he said ways need to be found to incentivize school districts to increase their share of contributions. He provided a general breakdown on state and local school district costs, and commented that the Arkansas Education Association (AEA) believes the primary responsibility for health insurance rests with the employer. Mr. Nagel additionally discussed cultural beliefs that contribute to the problems of the program and provided alternatives for improving funding.

- o original rationale for setting up the public school employee program,
- o ways to increase participation in the program,
- o funding Matrix, not a spending Matrix,
- o making health insurance a categorical in the Matrix, and
- o distribution of funds that have not been spent.
