<u>SB260</u>	J. Bryant	TO AMEND THE LAW CONCERNING THE COLLECTION OF COURT FINES, FEES, OR COSTS AFTER DEFAULT.
<u>HB1479</u>	Warren	TO AMEND THE LAW CONCERNING SCRIVENER'S AFFIDAVITS; AND TO ALLOW A LICENSED ENGINEER, SURVEYOR, OR NOTARY PUBLIC TO EXECUTE AND RECORD A SCRIVENER'S AFFIDAVIT IN CERTAIN CIRCUMSTANCES.
<u>SB277</u>	J. Bryant	TO AMEND THE COMPREHENSIVE CRIMINAL RECORD SEALING ACT OF 2013; AND TO PERMIT THE FILING OF A NEW UNIFORM PETITION TO SEAL A MISDEMEANOR VIOLATION OF THEFT OF PROPERTY AFTER TEN YEARS HAVE ELAPSED SINCE THE THEFT.
