Repeal: Much of the information in this publication is already found in the Minimum Licensing Standards for Child Welfare Agencies (which apply to DCFS foster and adoptive homes), which is promulgated by our sister Division of Child Care and Early Childhood Education/the Child Welfare Agency Review Board, so there is no need for a replication of this information in a separate DCFS publication. Any information specific to DCFS foster and adoptive homes only and not found in Minimum Licensing Standards for Child Welfare Agencies will be included in a forthcoming revised version of DCFS PUB-30: Foster Parent Handbook to avoid duplication of information. This also streamlines the amount of information provided to DCFS foster and adoptive parents -- rather than receiving two different publications with similar information, they will only receive one publication with all applicable information in once comprehensive document.
