PROCLAMATION

TO ALL TO WHOM THESE PRESENTS COME -- GREETINGS:

E.O. 24-03: EXECUTIVE ORDER TO SUPPORT MOMS, PROTECT BABIES, AND IMPROVE MATERNAL HEALTH

WHEREAS: Healthier moms have healthier pregnancies and healthier babies;

WHEREAS: The key to maternal health in Arkansas is overall women's health;

WHEREAS: Each year, nearly 10,000 pregnant women in Arkansas wait until after the first trimester of pregnancy to see a doctor;

WHEREAS: Each year, at least 1,100 pregnant women in Arkansas wait until they are i labor to see a doctor, which is nearly one out of every thirty-tw pregnancies;

WHEREAS: Arkansas is the most pro-life state in the country; and

WHEREAS: We must address the prenatal care crisis, protect women, and suppobabies.

NOW, THEREFORE, I, SARAH HUCKABEE SANDERS, acting under the authorit vested in me as Governor of the State of Arkansas, do hereby order the following:

- (1) That there shall be established the Arkansas Strategic Committee for Maternal Health (the "Committee").
 - a) The Committee shall be composed of:
 - i. The Secretary of the Department of Health;
 - ii. The Deputy Director for Public Health Programs;
 - iii. The Secretary of the Department of Human Services;
 - iv. The State Medicaid Director;
 - v. The Secretary of the Department of Education;
 - vi. The Arkansas Surgeon General; and
 - vii. The Chair of The Arkansas Maternal Mortality Revie Committee.
 - b) The Committee shall engage legislators, advocacy organization health care providers, and other stakeholders in a Matern

Health Working Group (the "Group") to provide input as support the development of a statewide Strategic Materr Health Plan (the "Plan").

- (2) The Plan will develop strategies to:
 - a) Improve education regarding women's and maternal heal especially prenatal and postpartum visits;
 - b) Improve maternal health before, during, and after pregnancy;
 - c) Increase access to quality maternal health services; and
 - d) Improve statewide coordination for maternal health data a reporting.
- (3) Upon developing the Plan, the Committee and Group shall provirecommendations to the Governor on any specific actions or legislation needed to facilitate this Order's directive.
- (4) The Arkansas Department of Health, Arkansas Department of Hum Services, and Arkansas Surgeon General, in collaboration wi stakeholders, shall:
 - a) Take immediate steps to enroll pregnant and postpartum women in Arkansas with available health coverage options, streamline coverage transition processes, and eliminate gaps is care;
 - b) Create a pilot program targeting five counties with low rates prenatal care designed to increase the percentage of women was access prenatal care in the first trimester and reduce incident of women who receive no prenatal care prior to delivery;
 - c) Reprioritize existing resources to develop a multi-agen maternal health education and advertising campaign;
 - d) Explore opportunities to foster maternal health innovations ar improvements, including but not limited to grants, publicprivate partnerships, and changes to the Medicaid program;
 - e) Expand the use of evidenced-based healthcare treatme processes and protocols for pregnant and postpartum wom across Arkansas hospitals;
 - f) Develop a statewide data and analytics reporting structure if maternal health; and
 - g) Explore strategies to expand telehealth, home visiting, doulcommunity health workers, and other reforms identified by t Committee and Group.
- (5) Within six months of the effective date of this Order, the Committee shall provide the Governor with an update on the items listed in Section 4.

This Order shall become effective upon its signing and shall remain in f force and effect until amended or rescinded by further executive orders.
