# Consideration to Approve the August 14, 2024, September 10, 2024, and September 11, 2024, Meeting Minutes [Exhibits B1-B3]

#### Consideration for Adoption of Interim Study Proposal (ISP) [Exhibits C1-C5]

Lud Kozlowski, Vice Chair, Arkansas Governor's Council on Developmental Disabilities; Jonathan Taylor, Executive Director, Arkansas Governor's Council on Developmental Disabilities; Logan Collins, Arkansas Autism Foundation; and Representative Pilkington; spoke in favor of ISP 2023-117 regarding the Blue Envelope Program as it relates to individuals with disabilities.
