28	SECTION 1. Arkansas Code § 17-80-402(4), concerning the definition of	
29	"professional relationship" in the Telemedicine Act, is amended to read as	
30	follows:	
31	(4) "Professional relationship" means at minimum a relationship	
32	established between a healthcare professional and a patient when:	
33	(A) The healthcare professional has previously conducted	
34	an in-person examination and is available to provide appropriate follow-up	
35	care, when necessary, at medically necessary intervals;	

1 (B) The healthcare professional personally knows the 2 patient and the patient's relevant health status through an ongoing personal or professional relationship and is available to provide appropriate follow-3 4 up care, when necessary, at medically necessary intervals; 5 (C) The treatment is provided by a healthcare professional 6 in consultation with, or upon referral by, another healthcare professional 7 who has an ongoing relationship with the patient and who has agreed to 8 supervise the patient's treatment, including follow-up care; 9 (D) An on-call or cross-coverage arrangement exists with 10 the patient's regular treating healthcare professional or another healthcare professional who has established a professional relationship with the 11 12 patient; (E) A relationship exists in other circumstances as 13 14 defined by rule of the Arkansas State Medical Board for healthcare professionals under its jurisdiction and their patients, including a 15 relationship established with store-and-forward technology in conjunction 16 17 with audio interaction and a review of clinical information; or 18 (F) A relationship exists in other circumstances as 19 defined by rule of a licensing or certification board for other healthcare 20 professionals under the jurisdiction of the appropriate board and their 21 patients if the rules are no less restrictive than the rules of the Arkansas 22 State Medical Board; 23 24 SECTION 2.
