- (3) Best practices for health care delivery across the nation;
- 2 (4) The medical procedures and practices allowed under the
- 3 Governor's declaration of a disaster emergency under the Arkansas Emergency
- 4 Services Act of 1973, § 12-75-101 et seq., regarding the coronavirus disease
- 5 2019 (COVID-19) to prevent the spread of an epidemic or contagious disease
- 6 and an analysis of the long-term benefits of continuing those practices;
- 7 (5) All authorizations provided under federal law relating to
- 8 healthcare profession scope of practice, including without limitation a
- 9 comparison of Arkansas laws and federal laws that are either restrictive or
- 10 permissive;

- 12 limitation Medicare and Medicaid reimbursement rates and how those compare

- 16 residence for practice in those healthcare professions;
- 17 (8) Any healthcare scope of practice limitations in Arkansas
- 18 that may be creating barriers to healthcare professionals staying in Arkansas
- 19 or moving to Arkansas as compared to other states;
- 20 (9) Issues with accessibility to health care and to healthcare
- 21 professionals in areas of the state that are a result of limitations on
- 22 medical profession scope of practice, including a comparison with
- 23 accessibility issues that exist in other states; and
- 24 (10) The need for healthcare professionals in the state as
- 25 compared to the availability of healthcare professionals from Arkansas
- 26 institutions of higher education that provide medical profession training,
- 27 including without limitation an examination of rates of graduation both
- 28 currently and as projected.
