15 TO REDUCE THE SIZE OF THE STATE HIGHWAY  
16 SYSTEM.

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20  
21 *Section 1. Arkansas Code § 27-67-201 is amended to read as follows:*  
22 *27-67-201. Designation generally.*

23 *(a)(1) State highways are declared to be those primary roads and*  
24 *secondary roads and connecting roads heretofore designated by the State*  
25 *Highway Commission, as shown by a map on file in the office of the*  
26 *commission, entitled "Map of the State of Arkansas Showing State Highway*  
27 *System", and marked "Revised March 1, 1929", including those portions of*  
28 *roads extending into or through incorporated towns and cities.*

29 *(2) The commission ~~is required to~~ shall preserve the map as a*  
30 *permanent record.*

31 *(b)(1)(A) The commission ~~is empowered~~ may, with any necessary consent*  
32 *of the proper federal authorities, ~~to make, from time to time,~~ necessary*  
33 *changes and additions to the roads designated as state highways that it may*  
34 *~~deem~~ deems proper.*

1                    (B) and The changes or additions shall become effective  
2 immediately upon the filing of a new map as a permanent and official record  
3 in the office of the commission.

4                    (2) However, except as provided in subsection (c) of this  
5 section, the commission shall not have authority to eliminate any part of the  
6 highway system.

7                    (c) The commission may eliminate from the state highway system those  
8 state highways that:

9                    (1) Terminate on one end without connection to another state  
10 highway; or

11                    (2) As determined by the commission:

12                    (A) Have an average daily traffic count of less than two  
13 thousand (2,000) motor vehicles; and

14                    (B) Are used primarily for local traffic.
