MEETING SUMMARY

STATE AND PUBLIC SCHOOL LIFE AND HEALTH INSURANCE PROGRAM LEGISLATIVE TASK FORCE

Tuesday, March 11, 2014 1:30 p.m. Room 171, State Capitol Little Rock, Arkansas

Senator Jim Hendren, the Chair of the State and Public School Life and Health Insurance Program Legislative Task Force, called the meeting to order at 1:30 p.m.

Remarks by the Chair and Vice Chair

Senator Hendren, noting that all consultants were present, reminded everyone about the importance of cooperation in this undertaking. He remarked that a survey had been sent to every school district in the state requesting certain employment-related data. Senator Hendren said it is critical that the consultants to the Task Force receive the data by the deadline of March 14, 2014, in order to develop policy alternatives for the Task Force to consider.

Representative Copenhaver added that cooperation is vital in all areas. He stated the Task Force is very pleased with the response to date; but school districts with outstanding surveys should expedite their return.

Update on the Activities of the Task Force's Consultants

Presenter & Synopsis:

Mr. Jody Carreiro, Vice President, Osborn, Carreiro & Associates, Inc. was recognized. Using a handout, Mr. Carreiro reported that his firm is sharing information with Collier Insurance and the Employee Benefits Division (EBD), and communication among the parties has been good. He said various aspects of the Public School Employee (PSE) plan are continuing to be analyzed and actuarial costs for policy alternatives are being developed for inclusion in the pending report to the Task Force. Citing examples of items being reviewed contained in the handout, Mr. Carreiro went on to discuss the analyses of the behavior of large claims (Over \$50,000) in PSE plan in Arkansas compared to national averages.

Issues Included in the Discussion:

- source of data that drive the graphs,
- necessity of a plan-to-plan comparison both with like plans and with plans in the private sector,
- availability of figures for large claims in 2011 and 2012,
- expansion of the large claims analyses,
- rationale behind large claim analyses, and
- dollar amounts of the majority of claims.

Presenter & Synopsis:

Mr. Eric Helman, President and Chief Executive Officer, ContinuousHealth, LLC, was recognized. Mr. Helman updated members on data gathering and validation activities. He reported that, following a request to school districts to provide "hours worked" information directly to Collier Insurance, data from 30% of the districts, representing 23,863 employees, had been received as of March 10, 2014. He went on to discuss the preparations and consultations for the meeting on April 16, 2014. At the request of Senator Hendren, Mr. Helman presented a preview of the kind of data expected to be presented at the April meeting.

Issues Included in the Discussion:

- source and content of request made to the school districts,
- running scenarios before the April meeting, and furnishing information to Committee members for consideration.
- fixing the PSE plan first, then seeing if data points towards plan consolidation,
- using data on all publicly funded health insurance plans in Arkansas that the Bureau of Legislative Research (BLR) is gathering for an interim study as a possible resource,
- necessity for reform of the ASE plan which is on a track two or three years behind the PSE plan,
- looking at various strategies of a multi-choice plan design vs. a simplistic plan design, and
- looking at all "plays."

Senator Hendren announced that the Committees would pass over Item D, Discussion of Draft Amendment to House Bill 1045 of the Fiscal Session of 2014, and take it up in a meeting after the consultants have delivered their report on April 16th.

At the request of Senator Chesterfield and Senator Bledsoe, Senator Hendren stated that issues regarding the amendment to House Bill 1045, including Section 21(7)(A)(i), "By developing a nationwide centers-for-excellence program for healthcare," would be completely addressed when the amendment is covered.

Senator Hendren announced that there would be a deviation from the agenda, and the Committees would next take up Item G.

Discussion of Issues Regarding the Coverage of Bariatric Surgery by the Employee Benefits Division

Presenter & Synopsis:

Mr. Bob Alexander, Director, Employee Benefits Division, Arkansas Department of Finance and Administration, was recognized. Mr. Alexander said the Arkansas Center for Health Improvement (ACHI) does a lot of outsource work for EBD, including the Bariatric Surgery Program. He introduced Ms. Rosemary Summers to give a presentation on the program.

Presenter & Synopsis:

Ms. Rosemary Summers, Research Assistant, Arkansas Center for Health Improvement, was recognized. Ms. Summers reviewed the report, *Bariatric Surgery Costs for the Arkansas Employee Benefits Division*. She discussed the five-year bariatric surgery pilot program which is a benefit on state and public school employee health insurance plans. She noted that, at this point, about two years of non-clinical cost data are available. She covered the report's background and findings, including eligibility, enrollment, costs incurred, and surgery impact. She said that more than 500 surgeries have been performed during the first two years of the program, and at least 60 members are under review for services. She said the program ends December 31, 2017. She said she has been reviewing results of national studies that show trends in this type of surgery. Ms. Summers concluded by stating that data is not available on the long-term impact on the plan or on members' health benefits. She commented that what is known is that enrollment continues to increase, surgeries between year one and year two increased 73%, and that more time is needed to do a case-by-case analysis with claims and clinical data to show whether or not the program has had an impact.

Issues Included in the Discussion:

- issues in determining per member/per month cost,
- expectations that enrollment and costs with regard to the pilot program will increase in 2014,
- regulatory authority of EBD,
- cost for and number of individuals suffering from Type 2 diabetes or hypertension undergoing the surgery,
- statistics by plan, i.e., Gold, Bronze, or Silver, of those involved in bariatric procedures,
- deadline for making changes in the administration of the PSE plan,
- whether bariatric surgery is covered by either fully-insured or self-insured private insurance plans in Arkansas.
- legislative requirements and other mandates contributing to the rise in costs of the PSE plan,
- comparison of ASE and PSE plan coverage to coverage in the private sector, and
- distinguishing between mandatory and non-mandatory coverages.

Senator Hendren announced that he was going to ask that issues of compliance with providing coverage, along with the draft amendment, and any other cost-saving measures be put on the agenda for the May meeting of the Task Force. He stated that a lot of decisions are going to have to be made between now and May in order to present the preliminary report and recommendations to the General Assembly in June.

Mr. Marvin Parks and **Mr. Leo Hauser**, representing Johnson & Johnson, were recognized. Mr. Parks made preliminary comments regarding the issues raised by the Task Force's discussion of bariatric surgery. He offered to provide the Committees with additional information regarding issues surrounding this procedure once a meeting has taken place with the EBD. Mr. Hauser thanked Senator Hendren for opening the door for having the conversations with EBD and the Committees.

Senator Hendren observed that there were three (3) options as he saw it concerning the Bariatric Surgery Program:

- 1. We can continue as is, realizing that we are going to spend \$6 million in 2015.
- 2. We can limit the program by strict criteria to admissions which would dramatically reduce the expense.
- 3. We can put the program on pause either temporarily or permanently.

Senator Hendren requested data from Mr. Parks and Mr. Hauser on long-term savings over a ten- to twenty-year period based on available information. Senator Hendren asked Mr. Alexander if he was of the opinion that the State and Public School Life and Health Insurance Board (Board) had the authority to make programmatic changes without statutory authorization. Mr. Alexander stated that he believed the Board had that authority.

Senator Hendren announced that the Committees would return to Item F on the agenda.

Discussion of the Subrogation Process Used by the Employee Benefits Division

Presenter & Synopsis:

Mr. Bob Alexander, Director, Employee Benefits Division, Arkansas Department of Finance and Administration, was recognized. Mr. Alexander discussed a Health Advantage State and Public School Employees report prepared by Trover Solutions documenting the savings by EBD through subrogation. In response to a previous question concerning an automobile wreck, Mr. Alexander stated that the courts in Arkansas have applied the made-whole doctrine in subrogation cases. (The made whole doctrine requires that the insured be fully compensated for their loss before the insurer can recover from a settlement or judgment.) Under the made-whole doctrine, an insured's loss includes pain and suffering and there is almost nothing left to pay medical bills. The subrogation process for automobile claims has decreased from 150 cases in 2012 to 41 cases in 2013. The Trover Solutions report indicates there are 22 open automobile claims. Subrogation for automobile claims is typically based off the claims database and savings from these types of claims have been reduced. Utilizing accident codes or codes related to accidents, the subrogation process is considered uniform under a typical insurance plan.

Senator Rapert was recognized. He thanked Mr. Alexander for his report. He said he would follow-up through the Insurance and Commerce Committee with the issue of subrogation to see how Arkansas compares with other states.
