Update on the Fiscal Status of the Employee Benefits Division (EBD)

Presenter:

Mr. Chris Howlett, Director, Employee Benefits Division, Arkansas Department of Finance and Administration, was recognized. Mr. Howlett reviewed Public School Employees (PSE) Financials for May 2016 on page 25 of Exhibit F. He said the Net Assets Available are \$56,330,018; and are trending about the same as in May 2015. He next directed members to Arkansas State Employees (ASE) Financials for May 2016 on page 13. Following a review of these financials, he said the Net Assets Available are \$37,667,990, a little less than for May 2015, and a situation that needs to be watched; however, he did not think it was alarming.

As there were no questions from members, Senator Cheatham opened up questioning to the audience.

Mr. Mike Anderson, Lobbyist, Arkansas Blue Cross Blue Shield, was recognized, and requested a general comparison between 2016 and 2015 pharmacy expenses.
