<u>SB455</u>	J. Bryant	TO ALLOW REGULATION OF HEMP PRODUCTS BY ARKANSAS TOBACCO CONTROL; AND TO AMEND THE UNIFORM CONTROLLED SUBSTANCES ACT TO REMOVE CERTAIN SUBSTANCES THAT ARE DEFINED AS HEMP PRODUCTS.
<u>SB466</u>	J. Dismang	TO PLACE A MORATORIUM ON CERTAIN HEIGHTS OF WIND POWER DEVICES; TO REQUIRE THE ARKANSAS STATE GAME AND FISH COMMISSION TO STUDY ON THE EFFECTS OF WIND POWER DEVICES; AND TO DECLARE AN EMERGENCY.
