8	consumers alike; and

10	WHEREAS, retail convenience stores have long been targets for nighttime
11	robberies and other crimes; and

13	WHEREAS, it was once estimated by law enforcement officials that six
14	percent (6%) of all robberies of businesses in the United States involved
15	retail convenience stores; and
16	
17	WHEREAS, employees in the retail trade sector are at a higher risk of
18	violence and homicide than in other industry sectors, and within the retail
19	sector, employees in gasoline stations or retail convenience stores, are at a
20	higher risk compared with employees in other types of retail and the overall
21	workforce; and
22	
23	WHEREAS, according to 2021 Federal Bureau of Investigation crime data,
24	there were over twenty-two thousand seven hundred eighty-eight (22,788)
25	incidents of violent crime that occurred at retail convenience stores in the
26	United States, double the incidents of violent crime that occurred at retail
27	convenience stores in 2017, and represented three percent (3%) of the
28	nation's total violent crime statistics for 2021; and
29	
30	WHEREAS, the increase in nighttime robberies and other crimes at retail
31	convenience stores heightens the risk of danger, exposure to violent
32	incidents, and crime to consumers and employees; and
33	
34	WHEREAS, some states have mandated certain minimum security measures at
35	retail convenience stores to enhance and protect customers and employees of
