17	TO CLARIFY PAYMENT FOR HEALTHCARE
18	SERVICES PERFORMED BY CERTAIN OUTPATIENT
19	SURGERY CENTERS.

22	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23	
24	SECTION 1. Arkansas Code § 23-79-115(a), concerning the rates of
25	insurance policy reimbursement for services, is amended to read as follows:
26	(a)(l) <u>(A)</u> Notwithstanding any provisions of any individual or group
27	accident and health insurance policy, or any provision of a policy, contract,
28	plan, or agreement covering hospital or medical services, in <u>In</u> cases in
29	which the <u>insurer, under a</u> policy, contract, plan, or agreement <u>,</u> provides for
30	payment or reimbursement for any healthcare service provided by hospitals or
31	related facilities a hospital or related facility as defined in § 20-9-201 or
32	§ 20-10-213, the person entitled to payment or reimbursement for <u>the</u>
33	healthcare services service under the policy, contract, plan, or agreement,
34	including without limitation a healthcare provider, is entitled to payment or
35	reimbursement on an equal basis for the <u>healthcare</u> service when the

1	<u>healthcare</u> service is provided by facilities <u>a facility</u> licensed as <u>an</u>
2	outpatient surgery centers <u>center</u> under §§ 20-9-214 and 20-9-215.
3	(B) Subdivision (a)(1)(A) of this section applies
4	notwithstanding any provision of:
5	(i) An individual or group accident and health
6	insurance policy;
7	(ii) A policy, contract, plan, or agreement covering
8	hospital or medical services;
9	(iii) A network participation agreement; or
10	(iv) An agreement between an insurer and a
11	healthcare provider.
12	(2) This subsection applies to <u>an</u> insurance policies <u>policy</u> and
13	hospital service corporation contracts <u>contract</u> that are <u>is</u> delivered or
14	issued for delivery in this state more than one hundred twenty (120) days
15	after July 6, 1977, and to such <u>any</u> other contracts, plans, or agreements
16	contract, plan, or agreement that are is entered into or effectuated in this
17	state more than one hundred twenty (120) days after July 6, 1977 <u>, including</u>
18	without limitation a network participation agreement or an agreement between
19	an insurer and a healthcare provider.
20	(3)(A) An insurer may consider and apply the Patient Protection
21	Act of 1995, § 23-99-201 et seq., and § 23-99-801 et seq. when setting a rate
22	for payment or reimbursement for a healthcare service that is provided by an
23	outpatient surgery center licensed under §§ 20-9-214 and 20-9-215.
24	(B) An insurer shall not set a rate for payment or
25	reimbursement for a healthcare service that is less than ninety percent (90%)
26	of the average rate of payment or reimbursement for a healthcare service by
27	an insurer under the relevant Current Procedural Terminology code for a
28	procedure billed as a hospital outpatient service for a county where the
29	outpatient surgery center licensed under §§ 20-9-214 and 20-9-215 is located.
