SJR9	M. Johnson	AN AMENDMENT TO THE ARKANSAS CONSTITUTION TO REVISE THE PROCESS FOR SUBMITTING INITIATIVES, REFERENDA, AND CONSTITUTIONAL AMENDMENTS TO THE VOTERS FOR APPROVAL.
