AUTOMATED RECORDS SYSTEM FUND GRANTS

Automated Records System Fund Grants were established pursuant to Act 615 of 2007 for the purpose of providing grants to class 1 thru 5 counties to implement and/or upgrade automation of the county recorder's office. The ARSF is administered by a committee comprised of the county recorderss of class 6 and 7 counties, known as the Automated Record System Funds Committee, which funds the grants by monthly contributions of \$ 1.00 per document recorded in their counties. The grants have been used for everything from scanning old records to preserve them to purchasing a complete document management system to purchasing a copier, server, or printer. The smallest grant we have given is \$ 2,000.00 all the way up to \$ 65,000.00. The first grants were awarded in June, 2008 to eight counties. They were:

Since this fund was established in 2007 we have awarded almost \$ 1.3 million dollars in grants to the counties. As you can see from this list some counties have applied and been given grants multiple times. We encourage them to submit their applications in phases if possible so that if we do not have enough money to give them the full amount we can grant one phase then they can reapply for the next phases at a future time. I'll use Lynn Stillwell from Phillips County as an example, she has been given three grants totaling \$ 87,500.00 for scanning and indexing her records, her first application broke down the project into three phases and we have given her grants to complete this process with the last one being awarded last October at our Circuit Clerks Association meeting. We are very proud of the progress these counties have been able to make using this money, and there are now 10 class 6 and 7 counties to share in the donations to the grant fund. Some of these counties purchased complete document management systems that they never would have been able to afford without the grant money. We always try to give at least two large grants to counties trying to purchase document management systems and sometimes are able to give more. I feel that this fund is very important to Arkansas Counties and have been contacted by surrounding states wanting to know about how we were set up for this so they could pursue something similar in their states. The first grant cycle we only had eight applications and were able to award them everything they asked for, since then we have had more applications than we could fund and have had to cut some grants or not give to some counties, which we do not like to do, but we only have so much money to work with and there is a great need for this money in the counties. We appreciate the help of the Arkansas Legislature in getting this set up and passing Act 615 of 2007.
