21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23	SECTION 1. Arkansas Code § 27-50-1203(a) and (b), concerning the	
24	creation of the Arkansas Towing and Recovery Board, are amended to read as	;
25	follows:	
26	(a)(1) There is hereby created the Arkansas Towing and Recovery Boa	ırd
27	consisting of $\frac{1}{nine}$ (9) $\frac{1}{nine}$ seven (7) members appointed by the Governor and	
28	confirmed by the Senate, who shall serve terms of three (3) years.	
29	(2)(A) Four (4) Two (2) members shall be appointed from the	
30	towing industry and shall be licensed by the board to engage in nonconsent	.
31	towing, with one (1) each of the members being a resident of each of the f	our
32	(4) congressional districts shall be appointed from the state at large.	
33	(B) Two (2) members who are permitted to engage in the	
34	consent-only business shall be appointed from the state at large.	
35	(C) Two (2) members <u>One (1) member</u> who are not associat	ed
36	with the towing industry shall be appointed from the state at large.	

1	(D) $rac{\mathit{One}}{\mathit{One}}$ $rac{\mathit{Two}}{\mathit{C1}}$ $rac{\mathit{C2}}{\mathit{C2}}$ $rac{\mathit{member}}{\mathit{members}}$ shall be appointed from
2	the insurance industry.
3	(b) $\underline{(1)}$ The appointed board members shall be residents of the State of
4	Arkansas at the time of appointment and throughout their terms.
5	(2)(A) During the term of appointment to the board, a member
6	shall not hold office in, serve in an executive or representative capacity
7	for, or hold a position in any nongovernmental towing industry organization.
8	(B) This subdivision (b)(2) does not limit a member of the
9	board from being a member in a nongovernmental towing industry organization.

11	SECTION 2. Arkansas Code § 27-50-1203(e)(1), concerning the Arkansas
12	Towing and Recovery Board, is amended to add two additional subdivisions to
13	read as follows:
14	(H) Requiring all entities permitted, licensed, or
15	regulated under this subchapter to maintain personnel at storage facilities
16	for eight (8) hours between the hours of 8:00 a.m. to 5:00 p.m. on any day
17	for which storage fees are charged; and
18	(I) Requiring all entities permitted, licensed, or
19	regulated under this subchapter to charge storage fees only for each twenty-
20	four-hour period following the time the entity takes possession of a vehicle,
21	implement, or piece of machinery.
