# Update—University of Arkansas for Medical Sciences (UAMS) Childhood Post-Infectious Autoimmune Encephalopathy (CPAE) Clinic [Exhibit F]

Dr. Aravindhan Veerapandiyan, Co-Medical Director CPAE Clinic-Arkansas Children's Hospital (ACH), Director Comprehensive Neuromuscular Program, and Medical Director Headache Clinic-ACH, Assistant Professor of Pediatric Neurology-UAMS, gave background information on the Regional Center of Excellence and provided a clinical update. Mr. Paul Ryan, Co-Founder and President, PACE Foundation, gave a brief overview of the PACE Foundation. Mr. Michael Keck, UAMS Institutional Relations Liaison, provided an overview of the Regional Center of Excellence collaboration between UAMS and ACH, its leadership changes, and the Center's full time nurse.

## Discussion of Acts 430, 637, and 1054 of 2021 [Exhibit G]

Ms. Alix Stephens, Legislative Attorney, Bureau of Legislative Research (BLR), explained Acts 430, 637, and 1054 of 2021. Ms. Jessica Beel, Legislative Attorney, BLR, explained Act 637 authorizes the Arkansas Medicaid Program to provide coverage for off-label use of drug treatments including IVIG, to Medicaid beneficiaries who are diagnosed with PANS/PANDAS.
