Consideration to Approve the January 10, 2022, Meeting Minutes [Exhibit B]

Update on the Medicaid Rule for Authorization of Off-Label Use of Drug Treatments to Treat Medicaid Beneficiaries Diagnosed with PANS/PANDAS

Mark White, Deputy Director and Chief of Staff, Legal, and Legislative Affairs, Arkansas Department of Human Services (DHS), gave an update on the DHS Medicaid rule in response to Act 637 of 2021, which is expected for legislative review in May and to be effective June 1, 2022.

Update from the University of Arkansas for Medical Science (UAMS) Regarding Clinic Data and Patient Resources [Presentation]

Michael Keck, Institutional Relations Liaison, UAMS, and Sandra Bennett, Nurse Coordinator, UAMS, presented information regarding the Children's Post-Infectious Autoimmune Encephalopathy (CPAE) program. Dr. Veronica Raney, Co-Medical Director CPAE Clinic-Arkansas Children's Hospital (ACH), Medical Director UAMS Child Study Center Clinic, ACH, Assistant Professor UAMS - Psychiatric Research Institute, discussed future trainings.

Discussion of Collaborative Physician Model and Arizona Grand Rounds

Michael Keck, Institutional Relations Liaison, UAMS, discussed working towards a Collaborative Physician Model similar to Arizona's through Grand Rounds with the state's network of pediatricians.

Discussion of developing a Statewide Crisis Network

Michael Keck, Institutional Relations Liaison, UAMS, explained plans to work with Crisis Intervention Centers statewide. Dr. Tumlison stated a UAMS brochure was distributed last month to Arkansas chapters of American Academy of Pediatrics and Arkansas Academy of Family Physicians.

Discussion of Arkansas PANS/PANDAS Advisory Council of Subcommittees
