

ADC is not considering Residential Burglary as a violent charge prior to 4/1/2015 when it was added to the list. If the residential burglary was prior to 4/1/2015 and now convicted of sexual assault, your client will serve 1/3 of his/her sentence less any good time earned. This is contingent upon no other prior convictions for violent or sexual crimes listed under 5-4-501 (d)(2).

Shelli:

We were forwarded your email regarding parole eligibility in reference to a person that may take a plea on Sex. Assault in 2nd degree as a habitual offender; the problem is that he has a residential burglary conviction from 2000, when it was not considered a violent felony.

It's my understanding that ADC does not consider residential burglary a violent felony if the plea was prior to April 1, 2015.

If that is the case, would our client be eligible for parole after serving 1/6 of his sentence, if he got all good time and everything; I understand that its discretionary, but I want to make sure under 16-93-609(b)(1) that the residential

burglary from 2000 will not trigger NO PAROLE. And I was also concerned under 16-93-615(h) where it says parole cannot happen until someone is 55 years old.

Any help would be appreciated.

Since both are considered violent felony or sex offenses, does he have to serve flat time under 16-93-609? My understanding, per PCO, was the ADC was not interpreting pre-2015 residential burglaries as violent offenses for purposes of parole eligibility. Is that still the case?
