## **SUMMARY OF SIGNIFICANT FINDINGS**

### **TRENDS IN POPULATION AND CRIME IN ARKANSAS & US**

- Reported crimes per 100,000 residents dropped by 1.0 percent between 2009 and 2010.
- Arkansas had a parole supervision rate in 2010 of 797 persons on parole per 100,000 residents. This was higher than the rates of all border states and of the US as a whole (312).
- The US as a whole utilized probation to a larger extent than Arkansas. The rate of persons on probation supervision for the US was 1,711 per 100,000 residents. The rate in Arkansas was 1,083. In contrast, Arkansas incarceration rate per 100,000 residents was larger than the US as a whole (511 for AR versus 454 for the US).

### **2011 PAROLE & PROBATION FORECAST – ACCURACY**

- Projections for the 2011 forecast were tracked from April 2011 to April 2012 (13 months). The active probation population was forecasted to an accuracy of +/-1.7 percent while inactive was forecasted to an accuracy of +1.7 percent. Active parole was forecasted to an accuracy of 0.4 percent and inactive parole to an accuracy of -4.8 percent.

### **PROBATION TRENDS**

- Probation admissions increased by 17.4 percent in 2011. This is in contrast to the three previous years where probation admissions were in decline. Probationer intakes decreased by 7.2 percent between 2007 and 2008. In 2009 admissions to probation supervision decreased a further 5.0 percent. Admissions decreased 5.9 percent in 2010.
- Probationers in 2011 were sentenced to an average term of supervision of 46.0 months, down from 46.6 months in 2010.
- The number of active probationers (at year end) increased by 7.8 percent between 2010 and 2011.
- In 2011 the active probation population increased by 1.9 percent (or 209 cases).

- At year end 2011, drug court cases accounted for 7.1 percent of the active probation supervision case load.
- In 2011, for probationers ending supervision, the average length of stay (LOS) under community supervision was 34.0 months.
- Probation discharges averaged a LOS of 42.9 months while technical revocations and new felony revocations averaged a LOS of 20.3 and 22.8 months respectively.
- Revocations (new charge and technical together) to the ADC accounted for 11.8 percent (1,188 persons) of probation releases in 2011.

## **PAROLE TRENDS**

- Parole intakes increased by 1.5 percent in 2011. Cases from the ADC accounted for a majority of the increase.
- Parolees in 2011 were sentenced to an average term of supervision of 58.4 months, up from 55.6 months in 2010.
- The active parole population grew by 6.1 percent year-end 2010 and year-end 2011.
- Parole technical revocations to the ADC accounted for 6.5 percent of parole releases in 2011 (or 543 cases)
  - 15.0 percent (1,516) of parole releases in 2010
  - 10.2 percent (836) of parole releases in 2009
  - 8.2 percent (683) of parole releases in 2008.
  - 5.3 percent (411 cases) of parole releases in 2007.
  - This number was 276 cases in 2006.
- Releases from parole supervision decreased by 4.2 percent between 2010 and 2011. Technical revocations decreased by 33.3 percent. New felony revocations decreased by 24.9 percent.
- Technical parole violators were supervised an average of 14.5 months before being revoked while new felony violators had served 17.3 months.

## **DCC FACILITIES**

- Central CCC saw no growth in its average daily population (ADP) between 2005 and 2011.

- Northwest saw an average annual increase in its ADP of 5.3 percent since 2008.
- Southwest CCC has seen a 3.6 percent average annual increase in its ADP since 2005.

## **PROJECTIONS**

- At the end of December 2011, the active probation population was 21,588. The population is projected to be 21,032 at year end 2012. By December 2022, the number of persons under active parole supervision is projected to be 27,050. The projected change represents average annual increases of 2.8 percent per year through the year 2022.
- At the end of December 2011, the inactive probation population was 10,250. The population is projected to be 10,265 at year end 2012. By December 2022, the number of persons under inactive parole supervision is projected to be 1,069.
- At the end of December 2011, the active parole population was 14,643. The population is projected to decrease to 14,227 in year end 2012. By December 2022, the number of persons under active parole supervision is projected to be 22,380. The projected change represents average annual increases of 4.7 percent per year through the year 2022.
- At the end of December 2011, the inactive parole population was 8,764. The population is projected to increase to 9,250 in 2012. By December 2022, the number of persons under inactive parole supervision is projected to be 1,487.
