

# Proposed Rule Amendment to 24 CAR § 10-811 – Survivors – Dependent Children – Return to Work Retirees

## 1. 24 CAR § 10-811(a).

- a. ATRS Staff Comment: When I read 10-811, it wasn't clear to me. Here is what it says: A dependent child annuity shall be payable to a surviving child of a retiree who dies after returning to work or a disability retiree: When I read ("red") it, I placed the emphasis on the word "or" as follows: A dependent child annuity shall be payable to a surviving child of a retiree who dies after returning to work or a disability retiree: I know that this wasn't the intent.
- b. **Response:** The proposed rule has been revised to change "surviving child of a retiree who dies after returning to work or a disability retiree" to "surviving child of a disability retiree or a retiree who dies after returning to work".

### 2. 24 CAR § 10-811(a).

- a. ATRS Staff Comment: Also, after the opening phrase above, the first word is "Qualifies". This also doesn't make sense to me as follows: A dependent child annuity shall be payable to a surviving child of a retiree who dies after returning to work or a disability retiree: (1) Qualifies as a dependent... (2) Has not been... Does the word "who" need to be placed before each of the numbers?
- b. **Response:** No, "who" does not need to be placed before each of the numbers. However, "if the child" should not be struck. The proposed rule has been revised to remove the strikethrough of "if the child".

# **Executive Summary Proposed Rule Amendment**

## 24 CAR § 10-811 — Survivors — Dependent Children — Return to Work Retirees

#### I. Purpose

The Arkansas Teacher Retirement System ("ATRS" or "System") requests the review and approval of proposed amendments to 24 CAR § 10-811— Survivors — Dependent Children — Return to Work Retirees.

On June 2, 2025, the Board of Trustees of the Arkansas Teacher Retirement System ("Board") voted to proceed with the promulgation process for 24 CAR § 10-811.

#### II. Authority

A.C.A. § 24-7-301 provides that the Board is responsible for the general administration and proper operation of the System and for implementing the Arkansas Teacher Retirement System Act, A.C.A. § 24-7-201 et seq.

A.C.A. § 24-7-305(b) gives the Board the authority to promulgate rules as it deems necessary from time to time in the transaction of its business and in administering the System.

Acts 2025, No. 225, which amended the law to permit a child of a deceased disability retiree and return to work retiree to receive a dependent child survivor annuity if the child was not designated as the disability retiree's or return to work retiree's option beneficiary.

#### III. **Amendments**

- 24 CAR § 10-811 has been amended to permit a child of a deceased disability retiree and return to work retiree to receive a dependent child survivor annuity if the child was not designated as the disability retiree's or return to work retiree's option beneficiary.
- Amended to revise "surviving child of a retiree who dies after returning to work or a disability retiree" to read "surviving child of a disability retiree or a retiree who dies after returning to work".
- Amended to remove the strikethrough of "if the child".

#### IV. Recommendation

The System recommends that the proposed amendments to 24 CAR § 10-811 be approved as proposed.
