Division of Child Care and Early Childhood Education Report for Act 131, 2019

The Division of Child Care and Early Childhood Education has reviewed promulgated Minimum Licensing Requirements for Child Care Centers and Family Homes. Attached is the report. In 2013, Child Care Aware of America released "We Can Do Better", a report that ranks states on meeting national standards for child care licensing. AR was ranked 41st overall-1st for oversight standards (monitoring of licensed facilities) and 49th for program standards. The reauthorization of the Child Care Development Block Grant which provides state's federal funding for child care assistance and a focus on improving the quality and professional development in child care and early childhood education added new requirements for licensing. AR receives \$80 million from the Child Care Development Funds. While AR does not exceed the nation in any licensing area, some of the new requirements have positioned the licensing standards to meet federal requirements/national standards.
