3	REQUESTING THAT THE ARKANSAS LEGISLATIVE COUNCIL REFER TO THE
4	JOINT COMMITTEE ON ECONOMIC AND TAX POLICY A REQUEST TO STUDY
5	IMPLICATIONS OF CHANGING THE TAX CODE SIMILAR TO THE STATE OF
6	MAINE TO ALLOW THE LIMITATION OF PURCHASING CERTAIN FOOD AND FOOD
7	INGREDIENTS BY RECIPIENTS OF THE SUPPLEMENTAL NUTRITION
8	ASSISTANCE PROGRAM.
9	
10	WHEREAS, the Supplemental Nutrition Assistance Program (SNAP) is
11	federally administrated by the Food and Nutrition Service (FNS) of the United
12	States Department of Agriculture (USDA) using federal funds; and
13	
14	WHEREAS, the eligibility criteria and types of food that can be
15	purchased are established by federal laws and regulations; and
16	
17	WHEREAS, state agencies administer the Supplemental Nutrition
18	Assistance Program at the state and local level based on the federal laws and
19	regulations; and
20	
21	WHEREAS, however, a state may alter the eligibility process or benefits
22	received under the Supplemental Nutrition Assistance Program by submitting a
23	waiver to the United States Department of Agriculture for approval; and
24	
25	WHEREAS, several states including Wisconsin, Delaware, Missouri, and
26	South Carolina have attempted to pass legislation to restrict the benefits of
27	the Supplemental Nutrition Assistance Program to the purchase of only healthy
28	food or the prohibition on junk food or luxury foods; and
29	
30	WHEREAS, Maine passed a resolution to require the Maine Department of
31	Health and Human Services to request a waiver to prohibit the use of food
32	supplement for the purchase of taxable food items in February 2015; and
33	
34	WHEREAS, in October 2015, the Maine Department of Health and Human
35	Services requested a waiver to prohibit a beneficiary of the Supplemental

1 Nutrition Assistance Program from purchasing candy and soft drinks which are 2 taxable under the Maine sales tax; and 3 4 WHEREAS, presently, the United States Department of Agriculture has not 5 granted approval for the waiver submitted by the State of Maine or any other 6 waiver submitted by a state or municipality; and 7 8 WHEREAS, legislation has not been introduced in Arkansas to prohibit a 9 beneficiary of the Supplemental Nutrition Assistance Program from purchasing 10 a particular food such as candy or soft drinks; and 11 12 WHEREAS, in Arkansas, the regular sales tax rate of six and one-half percent (6.5%) applies for prepared food and a reduced sales tax rate of one 13 14 and one-half percent (1.5%) applies to "food and food ingredients"; and 15 16 WHEREAS, candy and soft drinks that packaged by a manufacturer are 17 taxed at the reduced sales tax rate in Arkansas while candy and soft drinks that packaged by a supplier are taxed at the regular sales tax rate; and 18 19 20 WHEREAS, candy and soft drinks are a contributor to the adult obesity 21 rate in the State of Arkansas which is currently thirty-five and nine-tenths 22 percent (35.9%) and which is the highest adult obesity rate in the nation, 23 according to a recent report from the Trust for America's Health and the 24 Robert Wood Johnson Foundation; and 25 26 WHEREAS, to prohibit a beneficiary of the Supplemental Nutrition 27 Assistance Program from purchasing items such as candy and soft drinks 28 similar to the way the State of Maine is attempting, the definition of "food 29 and food ingredients" would need to be changed; 30 31 WHEREAS, the State of Arkansas has an interest in encouraging its 32 citizens to pursue healthier lifestyles to reduce healthcare costs and insurance costs in this state; and 33

WHEREAS, the General Assembly should investigate all possible methods available to encouraging healthier lifestyles among the citizens of Arkansas,
