33	of sixteen (16) years who the actor knows or who a reasonable person would								
34	know is under the age of sixteen (16) years age or younger with or without								
35	consideration a visual or print medium depicting sexually explicit conduct								
36	with the purpose to entice, induce, or groom the child thirteen (13) years of								

1	age or younger under the age of sixteen (16) years to engage in the following							
2	with a person when prohibited by law:							
3	(1)(A) Sexual intercourse;							
4	(2)(B) Sexually explicit conduct; or							
5	(3)(C) Deviate sexual activity; or							
6	(2) Offers, gives, or agrees to give money to a child under the							
7	age of sixteen (16) years with the purpose to induce the child under the age							
8	of sixteen (16) years not to disclose information regarding any of the							
9	following that the person has committed against the child under the age of							
10	sixteen (16) years:							
11	(A) An offense under § 5-14-101 et seq.;

25	(A) Class C felony if the actor is twenty-one (21) years							
26	of age or older; or							
27	(B) Class A misdemeanor if the actor is younger than

30	SECTION 2. Arkansas Code § 5-27-307(e), concerning sexually grooming a							
31	child, repealed.							
32	(e) It is not a defense to prosecution under this section that the							
33	actor does not know the age of the child or believes the child is fourteen							
34	(14) years of age or older.
