#### **Update on Medicaid Redetermination Process [Exhibit D]**

Lori McDonald, Deputy Chief of Staff, Department of Human Services (DHS), provided an update on the Medicaid redetermination process and the factors that determine continuous enrollment.

#### Discussion and Recommendation of Funding for Senior Citizen Centers [Exhibits E1-E3]

Jay Hill, Director, Division of Aging, Adult and Behavioral Health Services (DAABHS), DHS; Jason Kunau, Chief Financial Officer, DAABHS, DHS; and Brad Bailey, Executive Director, Area Agency on Aging of Northwest Arkansas, discussed the American Rescue Plan Act request for additional funds to provide an expansion of work services for the Area Agencies on Aging to recruit, hire, and train public health workers to respond to the COVID-19 pandemic and prepare for future public health challenges.

## DHS, Medical Services, Review of Rule Pertaining to Clinical Trials Attestation SPA and Provider Manual Updates [Exhibit F]

Elizabeth Pitman, Director, Division of Medical Services, DHS, and Mitch Rouse, Chief of Staff, DHS, discussed the proposed rule that outlines new Medicaid state plan requirements for assuring coverage of routine patient costs associated with participation in qualifying clinical trials.

## Arkansas Department of Health (ADH), Office of Administration, Review of Rule Pertaining to Rules for Declaratory Orders [Exhibit G]
